## **EXECUTIVE SUMMARY**

The Office of Community Investment and Infrastructure ("OCII"), as successor to the San Francisco Redevelopment Agency, is the lead agency responsible for administering the environmental review for private projects in the Mission Bay South Redevelopment Plan. The Golden State Warriors have proposed an Event Center and Mixed-Use Development (the "Project") on Blocks 29-32 in Mission Bay South. An environmental impact report is required for this Project in compliance with the California Environmental Quality Act ("CEQA"). OCII issued a Notice of Preparation on November 19, 2014 to inform agencies and interested parties about the proposed Project and to initiate the CEQA review process for the Project. The SEIR is tiered from the certified Mission Bay Final Subsequent Environmental Impact Report, which provided programmatic environmental review of the overall Mission Bay Redevelopment Plan.

The Draft SEIR, which is comprised of two volumes plus eight appendices in a third volume, was released on Friday, June 5<sup>th</sup>. The Draft SEIR and appendix is available to the public on OCII's website at: <a href="http://sfocii.org/index.aspx?page=61">http://sfocii.org/index.aspx?page=61</a>. The public comment period for the Draft SEIR is from June 5, 2015 to July 20, 2015. The Commission will hold a hearing to receive oral comments on the Draft SEIR on June 30, 2015 at 1:00 pm in City Hall, Room 416.

#### **DISCUSSION**

The public hearing on June 30, 2015 is to provide members of the public with an opportunity to provide oral comments on the Draft SEIR. In addition to accepting oral comments at the June 30<sup>th</sup> public hearing, written comments may be provided either by mail or by email. The Planning Department is assisting OCII with the review of the SEIR and will be collecting all mailed comments on OCII's behalf. Specifically, written comments may be submitted as follows:

Following the close of the public comment review period on the Draft SEIR, staff will prepare a Responses to Comments document, in which written and oral comments received on the Draft SEIR will be addressed. The Responses to Comments document will be released for public review and circulated to all persons, organizations, and agencies submitting comments on the Draft SEIR.

The Responses to Comments document and the Draft SEIR will constitute the Final SEIR. The Commission will hold a public hearing to consider the adequacy of the Final SEIR in complying with the requirements of CEQA. If the Commission finds that the Final SEIR complies with CEQA requirements, the Commission will certify the Final SEIR. The Final SEIR must be certified before OCII makes any decisions to approve, disapprove, or modify the Project. Staff anticipates that the Commission's consideration of certifying the Final SEIR would take place in Fall 2015.
