Thanks. I think we can accommodate your concern by 2018. That's still more than three years, and the more important accomplishment is that we are essentially at agreement in spirit and concept regarding the actual text on temporary signs.

I'd guess that another round of emails that edit out "Only" so the temp signs read "No Arena Traffic/ Local Access and Through Traffic" instead of ""No Arena Traffic/ Local Access and Through Traffic Only" might distract more than constructively guide, because:

- we are so close and
- discussions are now moving into how to address the possible consequences in case this Local Access Plan doesn't do enough to protect UCSF access for the 6:30 pm shift for nurses, etc.

But I see your point. "Only" implies that the PCO might not be doing his or her job if there's no screening. As we get closer to the logistical planning and staffing, we can smooth this over to make sure the PCO description and the text are in absolute sync. But we can only get there after we clear the larger milestones, so that seems the best focus for now.

I'm not comfortable using the word "ONLY" for any of the Owens signs. That is a regulatory meaning to me and when we use the word "only" we really need to mean it from a regulatory stand point. We can guide people not to use Owens but it is not a regulatory situation, it's a public arterial (thus the northbound LOCAL ACCESS ONLY on Owens at Mariposa to me is inappropriate).

I personally don't see what a PCO will do at Mission Bay Boulevard traffic circle and Owens.

Ricardo:

Kevin and we discussed seven -- what I understand to be! – temporary, Special Event-specific signs. His map is to show the location, not to redraw the network from where we last left it (he used an old base map).

I hope my revised version of Kevin's proposal looks OK to you:

- I replace Kevin's "280 Only" signage with "Through traffic" where local residents/drivers might want to go somewhere besides the hospital or 280... but in any case, not to the Arena.
- At a few points, I don't think we can limit I to Local Access Only" as I noted, explaining why.

Adam:

Ricardo has suggestions for two permanent signs that will already begin to help the screening

(did I get the Mariposa three-lane offramp sequence right?)
