Peter—

Thanks for double-checking with Ricardo.

To ensure we have an accurate record of what we are all comfortable with, I have accepted the edits in your previous markup of the Word document explaining the proposed signage and PCO duties, and added new redlined edits deleting the 2 instances of “Only” on the Owens Street signs I believe you/Ricardo are referring to, and also corrected the reference to “Owens Street” on the permanent sign at 7th Street which should instead refer to Mission Bay Drive. I’ve also added the locations of the 2 new permanent signs to the diagram of the Local Access Plan, also attached. Please let us know if this accurately captures everything.

What is the City’s plan for rolling the details of the LAP to the broader public?

Hi, Kevin:

He conveyed the one concern: using “Only” on the signs at Owens.

He feels the message that Arena Traffic stays off Owens could be adequately conveyed without “Only” – and that it suggests a “regulatory” condition (rather than a suggestion).

So, he'd suggest we go from:

"No Arena Traffic/ Local Access and Through Traffic Only"

to one sign that has:

"Arena Traffic" with arrow pointing toward east (to Mission Bay Blvd or to 16th), and
"Local Access and Through Traffic" with arrow pointing to Owens, and
a PCO there to help and guide (as per your description).

His actual message was that he was "not comfortable" with his word. I'm eager to see us go from 99% agreement to 100%, so I've texted him to vet his final okay with what we already drafted, but I'm interested to hear from you – since you asked – and it all seems to come down to this one word on this one street.

Feel free to call me tomorrow. My cell is 415.999.2387. I hope to have heard from Ricardo by then: I truly do value his advice as our Traffic Engineer.
