William and Kerstin:

Attached is a revised proposal for dedicated MTA operator restroom access, provided at no cost to the SFMTA. With the majority of special event shuttles staging on 16<sup>th</sup> street or Illinois Street the Warriors are providing access via a staff entrance to a private restroom immediately adjacent to the bus loading zone. This entrance will be staffed by a Warriors ambassador or private security guard and will not otherwise have general public access. For those buses staging on 3<sup>rd</sup> Street headed for the Transbay and Ferry terminals, operators would be guided to the existing restroom at 555 Mission Bay Blvd which is an approximately 5 minute roundtrip walk from the staging area. Let me know if this will work for your operators and I will confirm with the Warriors and their design team.
