- 1. Mariposa Street Restriping study which is part of Mitigation TR-10b. Cost estimate is \$20K. It came from Norman Wong in our Traffic Engineering subdivision.
- 2. One more traffic signal or additional PCOs at the intersection of I-280 SB off-ramp and Pennsylvania (this is a new mit measure that was added on 9/25 in response to a cumulative impact). Since we don't now whether it will require PCO or a traffic signal, I would just include whatever costs more. Because this is a cumulative impact, the Warriors only owe their fair share contribution of the traffic signal. Jose Farran is calculating that based on daily traffic volumes. I will see if he can give us a number by 10 am tomorrow.
