CHAIRPERSON ROSALES: Good morning. It is now 10:12 a.m. This is the Special Meeting of the Commission on Community Investment and Infrastructure, the Successor Agency Commission to the San Francisco Redevelopment Agency, for Tuesday, November 3, 2015.

Welcome to the members of the public.

Madam Secretary, could you please call the first item.

COMMISSION SECRETARY GUERRA: Thank you, Madam Chair.

The first order of business is Item 1, Roll Call.

Commission Members, please respond when I call your name.

Commissioner Mondejar.

COMMISSIONER MONDEJAR: Here.

COMMISSION SECRETARY GUERRA: Commissioner Pimentel.

1 COMMISSIONER PIMENTEL: Here.

2 COMMISSION SECRETARY GUERRA: Commissioner  
3 Singh.

4 COMMISSIONER SINGH: Here.

5 COMMISSION SECRETARY GUERRA: Commissioner  
6 Bustos.

7 COMMISSIONER BUSTOS: Here.

8 COMMISSION SECRETARY GUERRA: Madam Chair  
9 Rosales.

10 CHAIRPERSON ROSALES: Here.

11 COMMISSION SECRETARY GUERRA: All members of  
12 the Commission are present.

13 The next order of business is Item 2,  
14 Announcements.

15 A, The next regularly scheduled meeting of  
16 November 17<sup>th</sup>, 2015, will be held at 1:00 p.m. at City  
17 Hall, Room 416.

18 B, Announcement of prohibition of  
19 sound-producing electronic devices during the meeting.  
20 Please be advised that the ringing of and use of cell  
21 phones, pagers, and similarly sound-producing electronic  
22 devices are prohibited at this meeting. Please be  
23 advised that the Chair may order the removal from the  
24 meeting room of any persons responsible for the ringing  
25 of or use of a cell phone, pager, or other similarly



1 sound-producing electronic devices.

2 C, Announcement of time allotment for Public  
3 Comment. Please be advised a member of the public has

10 The next order of business is Item 3, Report  
11 on Actions Taken at a Previously Closed Session Meeting,  
12 if any. There are no reportable actions.

13 The next order of business is Item 4, Matters  
14 of Unfinished Business. There are no matters of  
15 unfinished business.

16 The next order of business is Item 5, Matters  
17 of New Business Consisting of Consent and Regular  
18 Agenda. First, the Consent Agenda. There is no Consent  
19 Agenda.

20 The next order of business is the Regular  
21 agenda. Items 5-A, 5-B, 5-C, 5-D, and 5-E related to  
22 the Golden State Warriors Event Center and Mixed-Use  
23 Development on Blocks 29 through 32 in Mission Bay South  
24 will be heard together but acted on separately.

25 5-A, Certifying the Subsequent Environmental

1 Impact Report for the Golden State Warriors Event Center  
2 and Mixed-Use Development on Blocks 29 through 32 in  
3 Mission Bay South under the California Environmental  
4 Quality Act (CEQA) and the CEQA Guidelines; Mission Bay  
5 South Redevelopment Project Area, Discussion and Action,  
6 Resolution No. 69-2015.

7 5-B, Adopting environmental review findings  
8 under the California Environmental Quality Act (CEQA)  
9 and the CEQA Guidelines, including the adoption of a  
10 Mitigation Monitoring and Reporting Program and a  
11 statement of Overriding Consideration in connection with  
12 the development of the Golden State Warriors Event  
13 Center and Mixed-Use Development at Mission Bay South  
14 Blocks 29 through 32; Mission Bay South Redevelopment  
15 Area, Discussion and Action, Resolution No. 70-2015.

22 5-D, Conditionally approving the major phase  
23 and Basic Concept/Schematic Design applications for a  
24 Golden State Warriors Event Center and Mixed-Use  
25 Development on Blocks 29 through 32 in Mission Bay

1 South, pursuant to the Owner Participation Agreement  
2 with FOCIL-MB, LLC; Mission Bay South Redevelopment  
3 Project Area, Discussion and action, Resolution No.  
4 72-2015.

5 And 5-E, Informational presentation on the  
6 Executive Director's determination regarding certain  
7 Event Center uses as allowed secondary land uses  
8 pursuant to the Mission Bay South Redevelopment Plan in  
9 connection with the Golden State Warriors Event Center  
10 and Mixed-Use Development on Blocks 29 through 32 in  
11 Mission Bay South; Mission Bay South Redevelopment  
12 Project Area, Discussion.

13 Madam Executive Director.

14 EXECUTIVE DIRECTOR BOHEE: Thank you, Madam  
15 Secretary.

16 Good morning to the Commissioners and good  
17 morning to the members of the public. Thank you so very  
18 much for joining us.

19 Commissioners, over the course of the last  
20 year you've held a number of public hearings and  
21 informational presentations on the proposed project.  
22 There are a number of actions before you for your  
23 consideration and action today.

24 We will have Executive Director Sally Oerth  
25 walk through the proposed actions before you in the

1 informational presentation. She'll also be joined by  
2 representatives of the project sponsor and the project  
3 consultant team.

4 With that...

5  
6 PRESENTATION BY DEPUTY DIRECTOR OERTH

7  
8 DEPUTY DIRECTOR OERTH: Thank you, Director  
9 Bohee.

10 Again, I'm Sally Oerth. I'm Deputy Director.  
11 I think Tiffany might have given me a promotion just  
12 now.

13 So, I'm here before you this morning to  
14 present a number of items related to the Event Center  
15 and the Mixed-Use Development on Blocks 29 to 32 in  
16 Mission Bay South that the Golden State Warriors are  
17 proposing.

18 So, I'd like to first go over our agenda and  
19 then we'll dive into it. So, our agenda for today is as  
20 follows.

21 I will highlight for you the various actions  
22 that are before the Commission today, walk you through  
23 the project site and description, go into more detail on  
24 the Subsequent EIR certification action that's before  
25 you and the C.E.Q.A. findings that you are being asked

1 to adopt.

2           There have been some project refinements since  
3 the Draft Subsequent EIR was published, and we'll walk  
4 through those -- and putting a number of  
5 transportation-related refinements. Then I will invite  
6 the project sponsor to come up and present their project  
7 and walk you through the designs as well.

8           And there are a number of other actions before  
9 us as well, so then we'll go into the second half and  
10 talk about the Design for Development amendments that we  
11 are recommending, and provide you information regarding  
12 the Executive Director's secondary use determination.

13           We'll highlight for you the various  
14 contracting goals and our Small Business Enterprise  
15 program goals in the -- for the project, describe the  
16 public outreach that has been undertaken for this  
17 project, and walk through the next steps.

18           So, again, the actions before you are in four  
19 separate resolutions: Certifying the final SEIR in  
20 Resolution 69-2015; Adopting C.E.Q.A. findings, which  
21 includes the findings themselves, along with the  
22 Mitigation Monitoring and Reporting Program, or the MMRP  
23 in Resolution 70-2015; Amending the Design for  
24 Development for Mission Bay South in Resolution 71-2015;  
25 and conditionally approving the major phase and the

1 combined Basic Concept/Schematic Design in Resolution  
2 No. 72-2015.

3 So, the project, as I mentioned, is located on  
4 Blocks 29 to 32 in Mission Bay South. You can see it  
5 here highlighted in blue. It's an 11-acre site of  
6 currently vacant property, and the Golden State Warriors  
7 completed their purchase of the site from Salesforce.com  
8 in October.

9 Here is the Site Plan showing the 18,064 seat  
10 multi-purpose Event Center. The project includes  
11 approximately 513,000 leasable square feet of office  
12 space and approximately 50,000 leasable square feet of  
13 retail space, 950 parking spaces, and 13 loading docks  
14 on site, and an additional 132 parking spaces at the 450  
15 South Street parking garage.

16 The site also includes 3.2 acres of open space  
17 for the project.

18 I'd like to note that the Site Plan, you can  
19 see, there is a Gatehouse element sort of between the  
20 two office towers. You'll see that the Basic Concept in  
21 Schematic Designs include a variant that does not  
22 include the Gatehouse.

23 This is because there is an easement that  
24 U.C.S.F. has that needs to be completed -- or, an  
25 agreement with U.C.S.F. is under way to agree to not

1 have the Gatehouse -- sorry -- to allow the Gatehouse to  
2 be in that easement.

3 I'd like to just correct. There is an error  
4 in my staff memo where I said that that process was  
5 completed, and I would just like to say that the project  
6 sponsor and U.C.S.F. have entered into an agreement that  
7 lays out the process to do that, and that's under way.  
8 It's just not officially complete, but everybody is  
9 moving forward with the understanding that the Gatehouse  
10 is the preferred scenario.

11 So, moving forward into the Environmental  
12 Review. So, OCII is the lead agency responsible for  
13 administering the Environmental Review of projects in  
14 Mission Bay South. And so, we've taken a number of  
15 steps in consultation with our colleagues at the City  
16 Planning Department to undertake this Environmental  
17 Review for this project, beginning with an Initial Study  
18 and Notice of Preparation that was issued on  
19 November 19<sup>th</sup>, 2014.

20 We held a Public Scoping Meeting on  
21 December 9<sup>th</sup>, 2014, and then the Draft SEIR was  
22 published on June 5<sup>th</sup>, 2014.

23 The Public comment period began on June 5<sup>th</sup>,  
24 and we extended it actually through July 27<sup>th</sup> for a  
25 total of 52 days. And then we published a Responses to

1 Comment document on October 23<sup>rd</sup>.

2           The Responses to Comment document responds to  
3 all the comments received during both the June 30th  
4 Draft SEIR hearing and all the written comments received  
5 during that 52-day Public Comment period, which ended on  
6 July 27<sup>th</sup>.

7           In addition, the Responses to Comments  
8 includes Responses to Comments received after the close  
9 of the Public Comment period, including a comment letter  
10 from the Mission Bay Alliance, dated October 27<sup>th</sup>,  
11 2015, concerning U.S. Army Corps of Engineers'  
12 jurisdiction.

13           And we've received a few additional comments  
14 that are not addressed in the Response to Comments  
15 document, including a letter from the Mission Bay  
16 Alliance, dated October 13th, concerning the SEIR  
17 alternatives analysis, and another letter from the  
18 Mission Bay Alliance, dated October 20th, concerning  
19 hazardous materials.

20           Finally, we received two letters yesterday,  
21 one from the Bay Area Air Quality Management District  
22 concerning the amount of ozone precursor offset be  
23 identified as a mitigation measure in the SEIR, and one  
24 from John Templeton regarding environmental justice.

25           These letters, along with written responses,



1 are included in your packets, and copies are available  
2 for the public as well.

3 None of these last-minute comments, though,  
4 change the conclusions reached in the SEIR concerning  
5 the impacts of the proposed project on the environment.

6 So, the Responses to Comments document itself  
7 is organized as follows: It contains a list of all the  
8 persons, organizations, and public agencies that  
9 commented on the Draft SEIR, copies of all of those  
10 comments received, written responses to those comments,  
11 a description of project refinements, a description of a  
12 project variant, and revisions to clarify correct  
13 information as needed in the Draft SEIR.

14 But since publication of the Responses to  
15 Comments, an errata sheet was prepared to correct minor  
16 editorial errors in the EIR, and that errata sheet was  
17 distributed to the Commissioners in your packets and is  
18 also available for the public here.

19 These text changes do not present any new  
20 information that would alter the conclusions presented  
21 in the EIR.

22 I would like to note two other changes that we  
23 want to note for you since we drafted the errata sheet.  
24 One is regarding in the MMRP, it references the  
25 Transportation Management Plan, or the TMP, as an

1 exhibit to the MMRP. Rather, instead, that is already  
2 provided as an exhibit in the appendix of the Draft SEIR  
3 in Volume III. So, it is not preprinted as a separate  
4 exhibit, so we will strike the reference as Exhibit 1 to  
5 the MMRP.

6           And then I'd also like to note in Volume V of  
7 the Response to Comments document in Chapter 14,  
8 U.C.S.F. has requested that we change the wording  
9 regarding the mitigation measure MTR 9-D, which is about  
10 the Event Center Exterior Lighting Plan. And in the  
11 fifth bullet they would like us to change the language  
12 where it describes the use of light configurations  
13 similar to those associated with the U.C.S.F. helipad  
14 landing area. We had language that said "and where  
15 feasible, locating primary outdoor lighted displays," et  
16 cetera, they would like to us remove the "where  
17 feasible." So, we will strike that out.

18           So, as noted before, the Public Comment period  
19 has closed on the SEIR, and the Commission action today  
20 is to consider certifying the SEIR, which means that the  
21 Commission has considered the adequacy and accuracy of  
22 the Final SEIR; is certifying that this Final SEIR has  
23 been presented to and considered by the Commission; is  
24 certifying that the Final SEIR was completed in  
25 compliance CEQA and reflects the Commission's

1 independent judgment and analysis; and will consider  
2 adoption of CEQA Findings, including the Mitigation  
3 Monitoring and Reporting Program.

4           The CEQA findings that the Commission is being  
5 asked to adopt include a project description, a  
6 description of the environmental impacts of the project,  
7 an evaluation of project alternatives and considerations  
8 that support approval of the project and rejection of  
9 alternatives, and a Statement of Overriding  
10 Considerations providing specific reasons in support of  
11 Commission actions and rejection of alternatives not  
12 included in the project.

13           The MMRP identifies the parties responsible  
14 and timing for implementing, monitoring, and reporting  
15 on the required mitigation measures. OCII will either  
16 directly monitor these measures or we will enter into  
17 agreements as necessary with other City departments to  
18 act as our designee.

19           So, now I'd like to note that -- the various  
20 project refinements that were included in the Response  
21 to Comments document. Again, none of these refinements  
22 changed staff's conclusions regarding the project and  
23 its environmental impacts.

24           These refinements include change of location  
25 for on-site generators, project redesign to reduce wind

1 hazards, refinements to the construction crane plan, and  
2 construction-related refinements including those related  
3 to on-site soil treatment and de-watering pump  
4 generators.

5 Also included were various refinements related  
6 to transportation. And I'd now like to ask Adam Van de  
7 Water from City's Office of Economic and Workforce  
8 Development to come up and present those transportation  
9 items to you.

10  
11 PRESENTATION BY PROJECT MANAGER VAN de WATER

12  
13 PROJECT MANAGER VAN de WATER: Thank you,  
14 Sally.

15 Good morning, Commissioners. Adam Van de  
16 Water in the Office of Economic and Workforce  
17 Development. I'm pleased today to walk you through some  
18 of the project refinements as they relate to  
19 transportation.

20 When we were last before you at our Schematic  
21 Design Workshop, we presented a number of transportation  
22 improvements that are coming to this neighborhood  
23 irrespective of the project.

24 Those are listed on the slide here and have  
25 not changed, but are pretty substantial investments on

1 the City's behalf into multi-billion dollar projects  
2 such as the Central Subway, the Transit Priority Lanes  
3 on 16th Street, the Transbay Terminal, the Priority  
4 Landing for the Water Emergency Transportation Agency in  
5 Golden Gate near the Ferry Building, completion of the  
6 street grid in Mission Bay, the Blue Greenway and others  
7 listed here. These are unchanged since our last  
8 discussion.

9           Sitting on top of those improvements are a  
10 number of specific improvements for the arena. This is  
11 our special event service buses, extra service on the T  
12 3rd, and coordination with the regional transit  
13 agencies.

14           But there is one difference here. As we  
15 started to refine our analysis as part of the Transit  
16 Service Plan, we identified the need for a potential  
17 central boarding platform, which is included as a  
18 variant in the document.

19           We released as part of the Draft EIR our  
20 intention to expand the closest existing platform to  
21 serve the arena. Those platforms currently are  
22 configured as a northbound- and a southbound-separated  
23 platform on either side of the intersection, and this  
24 contemplates potentially combining them. So, you'd have  
25 added capacity in both directions pre and post event.

1 So, we're studying that as a project variant in the EIR.  
2 That's one change since May.

3 We've also had about 18 months of conversation  
4 in the community with various stakeholders from the  
5 residential interests from Rincon through Mission Bay,  
6 Dogpatch, Potrero, and the Bayview, and throughout the  
7 eastern neighborhoods, as well as commercial interests  
8 from the biotech community in the Mission Bay, the  
9 U.C.S.F. Mission Bay Hospital, the Giants, and advocacy  
10 organizations such as the Bicycle Coalition, et cetera.

11 As a result of those conversations, we've  
12 added some additional parking control officers, and  
13 those are listed here.

14 It's a little difficult to see on the screen,  
15 but the stars that are shown on the map show three  
16 categories of parking control officers: Those that we  
17 analyzed as part of the Draft SEIR and released in the  
18 June draft, those that we added as a result of the  
19 analysis that was conducted as part of the Draft, and  
20 then a few additional to create what we've called the  
21 Local/Hospital Access Plan.

22 This is a specific plan to allow patients,  
23 doctors, and staff at the hospital to get to their  
24 destination without commingling with arena arrivals, and  
25 directing arena attendants to the arterial streets --

1 16th Street, 3rd Street, Mariposa -- and protecting 4th  
2 Street, Nelson Rising, Campus Way, and some of the  
3 interior circulation streets for local use. And we  
4 would use parking control officers and signage to  
5 separate that traffic.

6 We're also analyzing two parking lots to the  
7 south of the site as intercepts so that cars that are  
8 driving into the area would have both a place to park  
9 and a place to park that's away from the immediate  
10 adjacency of the venue itself so that we don't have  
11 conflicts with transit, bikes, peds, and hospital use.  
12 And those are shown here.

13 We'll be before the Port Commission a week  
14 from tomorrow on November 10th to consider the  
15 preliminary steps to realizing these as parking  
16 locations.

17 One of them is a 250-space lot, at grade, at  
18 19<sup>th</sup> and Illinois, which would serve the future Crane  
19 Cove Park/Pier 70 development, Dogpatch neighborhood,  
20 Mission Bay, and the Event Center.

21 And the other is further to the south off of  
22 Cesar Chavez Street. It's another Port-owned property  
23 called the Western Pacific Site just north of the border  
24 of Pier 80, which is a graded and gravel site that we  
25 use for construction staging and staging of delivery

1 vehicles for Moscone Convention events today, and we  
2 could use for overflow parking under kind of a  
3 dual-event scenario. So, a less frequent use, but when  
4 that's in use, there would be a free shuttle from that  
5 location to the Event Center.

6 In terms of capital and operating costs for  
7 transportation serving the Event Center, there are  
8 one-time costs of about 55 million. This is in 2014  
9 dollars so that we're comparing apples and apples across  
10 all sources and uses.

11 That 55 million will purchase four of the  
12 modern Siemens light-rail vehicles that the MTA is in  
13 the process of acquiring and will soon debut, as well as  
14 crossover tracks on the T 3rd line to add flexibility  
15 throughout the line to make sure we're not interrupting  
16 service further down line on the T 3rd; some  
17 signalization and other in-the-ground infrastructure.

18 It's about \$25 million in one-time sources,  
19 largely from the Transportation Impact Development Fee  
20 that the project sponsor will be paying to offset these  
21 costs, and about a \$30 million delta that we will be  
22 looking to finance with annual revenues generated by the  
23 Event Center.

24 In terms of annual revenues, we contracted  
25 with Economic & Planning Systems and had Keyser Marston



1 & Associates and the Controller's Office peer review  
2 those estimates.

3           They conservatively estimated that the Event  
4 Center net of the project's property taxing permit that  
5 stays in the neighborhood for infrastructure and  
6 affordable housing would generate about \$14.1 million  
7 per year once operational for the City's General Fund.

8           I won't go through the sources, but the  
9 sources are listed here. A portion of them are  
10 dedicated by the Charter or the voters, and those will  
11 continue to go to their dedicated sources.

12           So, if we break that \$14.1 million into its  
13 uses, 2.9 of which goes to those dedicated and  
14 restricted sources, 6.1 million is our estimate of  
15 operating costs. This is largely MTA to pay for those  
16 parking control officers, those extra bus drivers,  
17 trains and operators, transit fare inspectors, personnel  
18 and rolling stock to get people to and from the site.

19           And then there's a payment for the capital  
20 improvements, which is an estimate of the financing  
21 costs to pay that delta on capital.

22           And then there's two remaining funds. One is  
23 a dual-event reserve, which was an important thing to  
24 the community, to the hospital, to make sure under a  
25 peak condition when there is a lot of activity in the

1 neighborhood, we have available resources to add extra  
2 service where necessary. And that would be at the  
3 discretion of the Director of Transportation.

4 All of that included, we have 2.9 million for  
5 the dedicated and restricted existing funds, and an  
6 additional 1.5 million we think would be returned to the  
7 General Fund as a result of the project.

8 On October 6th, we introduced an ordinance at  
9 the Board of Supervisors to create a Controller's  
10 Reserve titled the Mission Bay Transportation  
11 Improvement Fund. A consideration of that will be heard  
12 in Budget and Finance Committee next Monday and  
13 subsequently at the full Board of Supervisors.

14 The fund, as envisioned, would set aside the  
15 funding to pay for the operating costs, the debt service  
16 costs, the dual-event reserve, and other resources so  
17 that we know that we have those funds into the future  
18 and we can continue to provide that service without  
19 degradation of service elsewhere in the City.

20 There is some built-in public review and  
21 accountability as part of that. It is still subject to  
22 annual appropriations by the Board of Supervisors, but  
23 should a future mayor or board allocate less than the  
24 full amount, there is a public process that is built in  
25 to make that a very transparent decision-making process.

1           As part of it, it also creates a five-member  
2 Advisory Committee to the Mission Bay Transportation  
3 Improvement Fund, which would advise the Director of  
4 Transportation both on annual budget requests and then  
5 on the expenditures of that dual-event reserve. So,  
6 they would be able to collectively provide advice to the  
7 MTA in order to reallocate transit service, traffic  
8 enforcement, or other services that the MTA provides.

9           I should also mention we are before the MTA  
10 Board later today with our resolution considering both  
11 CEQA adoptions and findings, as well as committing to  
12 the Transit Service Plan and the implementation of the  
13 Mission Bay Transportation Improvement Fund adopted by  
14 the Board.

15           I'll turn it back to Sally.

16           DEPUTY DIRECTOR OERTH: Thank you, Adam.

17           Before we turn to the design phase, I'll ask  
18 the Commission's patience to let me correct the record.

19           I misspoke when describing the correction that  
20 is needed for mitigation measure TR 9-D, so I'd like to  
21 just reread the correct correction.

22           So, again this is the Event Center Exterior  
23 Lighting Plan, and in the fifth bullet of that  
24 mitigation measure, it will now read, "Avoid the use of  
25 light configurations similar to those associated with

1 the U.C.S.F. helipad landing area," and then adding new  
2 language, "and where feasible, locate primary outdoor  
3 lighted displays and television, slash, lighted screens  
4 away from the project property line at 16<sup>th</sup> Street,  
5 South Street, or 3rd Street," and then strike "where  
6 feasible." Thank you.

7 So, now I'd like to turn to the other project  
8 approvals before you, including the Major Phase and the  
9 combined Basic Concept and Schematic Design.

10 As you may recall, staff has done several  
11 workshops for on this project, including a Draft Major  
12 Phase workshop in January of this year, and then we  
13 presented drafts of the Basic Concept and the Schematic  
14 Designs in a workshop to you in May of this year.

15 So, the project sponsor is here today to  
16 present to you information on the project, including  
17 updated Schematic Designs. And so, I'd like to invite  
18 Rick Welts, President of the Golden State Warriors, up  
19 there to kick off that presentation, and he'll be joined  
20 by David Manica of MANICA Architecture.

21  
22 PRESENTATION BY RICK WELTS,  
23 PRESIDENT OF THE GOLDEN STATE WARRIORS  
24

25 MR. WELTS: Good morning, Commissioners.

1           Actually, if you're checking any NBA scores on  
2 your smart phones, you don't have to adjust them. The  
3 Warriors did win an NBA game by 50 points last. So, if  
4 I hadn't seen that with my own eyes -- I'll rephrase my  
5 salutation to "Great morning, Commissioners."

6           It's great to be here, and thank you -- thank  
7 you for your time.

8           This day is actually the culmination of  
9 three-and-a-half years of a journey that began on Piers  
10 30 and 32 in May of 2012.

11           Little did we know what a circuitous route we  
12 would take to finally get to this point, but speaking  
13 for our ownership -- Joe Lacob, Peter Guber, and the  
14 entire organization -- we are thrilled to be here with  
15 you today.

16           Since moving to Mission Bay, we've been  
17 overwhelmed by the positive support and the  
18 encouragement from the neighborhood and the City as a  
19 whole.

20           In addition, we've been tremendously impressed  
21 with the work of OCII, Planning, the MTA, and the  
22 Mayor's Office.

23           And I'm really not just paying lip service  
24 when I say that the City team has played a very integral  
25 role in helping shape the plans you're gonna hear about

1 today.

2 And I think I'd be remiss without  
3 acknowledging just a few of the people that worked so  
4 hard to bring today to pass.

5 You've already met a couple of them. Sally  
6 Oerth, Jim Morales, Pedro Arce of OCII, Adam Van de  
7 Water and Ken Rich from the Mayor's Office, Chris Kern,  
8 Brett Bollinger and David Winslow from Planning, Peter  
9 Albert and Erin Miller from MTA.

10 And actually, as I was coming over here today,  
11 there is one other person that I wish was gonna be here  
12 with us today, and that was Jen Matz, whose hard, hard  
13 work is very much a part of what you're considering  
14 today. We lost her a year ago, but she's very much in  
15 the room today.

16 As you know, this project is also the product  
17 of extensive community process. Since coming to Mission  
18 Bay, we've had 11 separate public meetings with Mission  
19 Bay CAC, and more than 50 meetings with the Dogpatch,  
20 Potrero, and South Beach neighbors, U.C.S.F., and the  
21 Mission Bay biotech community.

22 That community dialogue has resulted in  
23 significant improvements to the project across the  
24 board. Of particular note is our recent announcement of  
25 agreements between the Warriors, U.C.S.F., and the City

1 to address hospital and neighborhood access during  
2 Warriors events that Adam just presented.

3           Along with all of the funding commitments just  
4 described, the Warriors have made an unprecedented  
5 commitment to cap the number of events held in our  
6 building under certain circumstances when the Giants are  
7 playing.

8           This cap on events, which has been called by  
9 Chancellor Hawgood the last tool in the tool box, is  
10 unprecedented for any other NBA or NHL arena anywhere in  
11 the county, and it really demonstrates our commitment to  
12 addressing U.C.S.F. concerns and those of the neighbors.

13           And while there's been very appropriate focus  
14 on transportation these last months, I'd be remiss if I  
15 didn't mention the project design itself.

16           You're gonna hear from David Manica. We have  
17 evolved the project designs considerably since our last  
18 presentation to you, and I think you will see  
19 substantial improvements to the pedestrian experience  
20 throughout the project and numerous refinements to the  
21 building architecture and materials.

22           And this will definitely be the entertainment  
23 portion of your day today, so I'm going to turn this  
24 over to David Manica, who really gets to have all the  
25 fun.

1 David.

2  
3 PRESENTATION BY DAVID MANICA,  
4 PROJECT ARCHITECT  
5

6 MR. MANICA: Thank you, Rick. That's a nice  
7 introduction.

8 Good morning, Commissioners. Nice to see you  
9 all again.

10 I want to start off, actually, by saying I'm  
11 from Kansas City, and today is a big day in Kansas City  
12 for us. After 30 years, we brought home a championship.  
13 And my family and my friends, along with every other  
14 person in the city right now, is celebrating, probably  
15 much like you all celebrated when the Warriors brought  
16 home their championship earlier this year.

17 And, you know, for me, the chance to work on  
18 these kinds of projects that unite cities like that is  
19 an incredible blessing, and I feel so lucky to do it.  
20 I've worked on projects for 20 years in the sport and  
21 entertainment industry around the world.

22 And the other thing that -- besides the fact  
23 that I think you'd be hard-pressed to find a building  
24 type that people enjoy going to or that unite cities  
25 more than these do, it's bigger than any one person.



1           I alone did not do this project. I get to be  
2 up here and speak to you about it, but there is an army  
3 of people behind me that are working on this day and  
4 night, and making sacrifices to make sure that this  
5 project is exceptional in every way.

6           And I'm also happy to say that for me, an  
7 unprecedented moment in teamwork on this is that  
8 50 percent of the team are -- we're on target for the  
9 50 percent threshold for SBA involvement on this  
10 project.

11           That means that approximately half the people  
12 working on this project are local small businesses. And  
13 I want to be sure and recognize them. A lot of them are  
14 here in the room today, and I'd like them to stand up if  
15 it's convenient for them.

16           (Members of the audience stand up.)

17           MR. MANICA: So, again, my voice is the voice  
18 of all these people that are working so hard to make  
19 this project something really special for this City, and  
20 I'm proud to be up here today to talk about it.

21           All right. Okay. I won't reiterate the Site  
22 Plan. Sally did a good job of walking you through it  
23 with the numbers, but I do want to take a moment to say  
24 that nothing significant has changed on the project  
25 since I spoke with you last time.

1           This is the same project that I presented to  
2 you and that you've seen before. There should be no  
3 significant surprises.

4           What there are, however, are improvements.  
5 I've said before that buildings are like people, and  
6 they grow up, and if we're lucky and you're disciplined  
7 and you're thinking, you get better with time. And  
8 projects are the same way.

9           So, what we're gonna talk about today is a  
10 part of the normal process for development, refinements,  
11 and improvements to a project. This should already look  
12 very familiar to you.

13           In your packages, we've created a series of  
14 before-and-after diagrams. Now, some of these  
15 refinements may be more difficult than others to notice,  
16 but I want to take the time to walk you through them so  
17 you can understand clearly how the project has been  
18 improved and bettered since we last spoke.

19           In May, the project was primarily steel and  
20 glass with a base of GFRC or precast. As we began to  
21 work through the interiors of the project, the arena,  
22 and also as we began to balance the exterior of the  
23 facade with the other buildings on the site -- the  
24 office buildings in the commercial and retail areas --  
25 it was important for me to think about the ways that the

1 arena could respond to that.

2           So, you can see that we've added some  
3 sustainable wood materials to the exterior of the arena.  
4 I have used this analogy before. Hopefully it makes  
5 sense to you. We've thought about the arena like a  
6 piece of fruit, where when you peel that fruit open and  
7 you see the juice and the meat inside, it's something  
8 different.

9           And that relates to the kinds of warmth and  
10 materials that we're bringing to the interiors of the  
11 building. They're beginning to reveal themselves on the  
12 exterior. And I think it really softens the exterior  
13 appearance of the building.

14           So, some of the soffits you can see there have  
15 been now dressed with this sustainable wood material.

16           The other thing we did was we began to think  
17 about the articulation of the metal panel on the  
18 exterior of the building. Before it was an  
19 unarticulated metal panel.

20           We're now beginning to accentuate and puncture  
21 that panel with a perforation that adds another level of  
22 scale to the exterior of the building.

23           And you can see that in some of the renderings  
24 as to, you'll see the dash marks in the exterior of the  
25 facade. That begins to add another level and scale of

1 the material. It actually reduces and -- in our minds,  
2 reduces the scale of the building and makes it more  
3 visually comfortable.

4           The big -- one of the big changes -- and I'm  
5 really excited about this one -- one of the big changes  
6 you can see is on the Bayfront Terrace. Previously, in  
7 May, that terrace was supported by columns. I think  
8 there were five -- one, two, three, four, five, six --  
9 seven columns that supported that cantilevered  
10 accessible space.

11           As we improved the design -- and I want you  
12 remind you -- maybe you didn't know this, but those  
13 columns came down and sat on top of the practice court  
14 area -- the two practice courts that the players  
15 practice in. So, those columns had to be transferred  
16 out before they go down and be supported on the  
17 foundations.

18           Well, as we reduced and refined the size of  
19 the Bayfront Terrace, we actually got it pulled back  
20 small enough to where we could eliminate the columns and  
21 the structural engineer was comfortable with removing  
22 the columns, because it actually decreased the  
23 complexity of the structure in order to actually support  
24 that portion of the building up at the roof level rather  
25 than transferring all those columns at the practice

1 court level.

2 That really creates an even more dramatic  
3 appearance, an iconic visual for the project on that  
4 side. So, we've been able to optimize the size and also  
5 optimize the structure in a visually exciting way.

6 Here you can see from a human scale walking  
7 around the project. Remember the pedestrian path I told  
8 you about before that links the main plaza clockwise apt  
9 around the arena to the southeast plaza.

10 Before, you can see there in the May drawings  
11 the columns that you had to walk under and through, and  
12 now those columns have disappeared, but we've added  
13 these wind gates.

14 Now, we did extensive studies on wind and the  
15 way wind travels around this project, and we found that  
16 we would be potentially at risk for wind turbulence  
17 around the pedestrian pathway as it's coming from  
18 north-northwest and spinning around the building.

19 So, these not only add a scale and a delight  
20 to the pedestrian pathway, making it feel more like an  
21 urban street, but they're also functional in the sense  
22 that they break the wind to make it a comfortable place  
23 to be.

24 Some minor improvements around -- on the 16th  
25 Street side. Further improvements and refinements to

1 the parking garage entrance and the accessibility and  
2 pathway up to the main plaza that continues the 360  
3 pedestrian walkway in and around the site.

4           And I want to take a moment to mention  
5 landscape materials. The landscape designers here  
6 locally are doing a fantastic job of breaking the  
7 exterior site into neighborhoods, neighborhoods that are  
8 articulated and supported with indigenous materials that  
9 are both friendly to the environment, sustainably  
10 supported with low irrigational water needs, but also  
11 very indigenous and appropriate for the site.

12           The streetscape -- the designers, as they  
13 designed -- I'm talking the landscape designers -- as  
14 they designed the softscapes, the landscape, and those  
15 areas, they're also working on the streetscape.

16           And I just want to point out -- I won't read  
17 all these to you -- I want to point out the level of  
18 detail that we're also thinking about.

19           The way the furniture around the site is going  
20 to -- where are the trash receptacles so that they're  
21 where they need to be to keep the site clean and, you  
22 know, comfortable?

23           Where are the bike racks? And we're providing  
24 more bike racks than we actually need to, because we  
25 want this to be a comfortable place for bikers to come

1 and attend events.

2 I'll let you read the rest, but the point is  
3 that we're creating a soft and urban environment that's  
4 comfortable for people 365 days a year.

5 Parking by use. We are continuing to study  
6 and refine the way the parking spots on site and around  
7 the site will be utilized for different events and  
8 allocated to the different program needs of the site and  
9 the development.

10 Sally took the time to mention the variant  
11 that we're seeking and currently in discussions with  
12 U.C.S.F. about.

13 This -- these diagrams here show what would  
14 happen if we did not or were not successful in  
15 negotiating that variant.

16 The Gatehouse is the fourth side of that urban  
17 room. I've talked about that before. It's the pavilion  
18 right at the center of 3rd Street on our block. It  
19 mitigates wind that would be coming down the street  
20 adjacent to it, but it also creates that room, that  
21 enclosure.

22 We've had the study and we've spent some time  
23 studying what would happen if that Gatehouse was not  
24 there, if it was relocated to the side of the  
25 pedestrian -- sorry -- if the plaza was actually

1 depressed.

2           And we -- unfortunately, in that scenario, we  
3 would end up with a two-height plaza. We would not have  
4 a continuous plaza level. It would be broken into two  
5 levels. It would be a little less functional. And I  
6 think depressed plazas in general have a difficult time  
7 succeeding in urban environments. But we are  
8 nonetheless studying the options there, and we certainly  
9 hope that we are successful with our preferred plan.

10           So, an aerial view. You've seen this shot  
11 before. It's simply been updated.

12           The incorporation of green roofs, the plaza  
13 space, the location of the arena, and the updated  
14 Bayfront Terrace, which has now been pulled back tighter  
15 to the building and is column-free.

16           This is a nice shot of the northwest corner of  
17 the site. We believe and understand still that a  
18 majority of spectators will be arriving from the Muni  
19 stop on this corner of the site.

20           We've been careful to think about what that  
21 experience is like as you enter the plaza as you pass up  
22 the eight feet from 3rd Street into the elevated plaza  
23 and enter the arena.

24           I've talked before about how this becomes the  
25 front porch of the project, and we expect it and want it



1 to be a place that people enjoy being, not just passing  
2 through. So, you can stop and have a sandwich or wait  
3 for a friend and enjoy that moment.

4 This is the shot after you walk up and you  
5 arrive in the plaza. Your back is now to the Gatehouse  
6 looking in the front entrance of the arena. Grand lobby  
7 space inside.

8 We've shown the plaza, the basketball court  
9 area, but it will do much more than that. This is the  
10 flexible space. Think of it as an outdoor multi-purpose  
11 room.

12 I've mentioned before it could be the pumpkin  
13 patch in October. It could be a Christmas tree farm in  
14 December. It could be Spring Festival. It can host  
15 outdoor community events at any time.

16 So, again, think of this as a fully flexible  
17 outdoor room in a place that people from all over the  
18 City and neighborhood can enjoy.

19 There it is. Looking again now, our back is  
20 to the arena, looking back at the Gatehouse there. You  
21 can see the Gatehouse in its preferred location.

22 So, this is a nice corner shot of the corner  
23 of 3rd and 16th. This is, let's say, the beauty shot of  
24 the commercial building, and I think the designers all  
25 along here in the City have done a fantastic job with

1 the design of these buildings.

2           You can see how the materials have even helped  
3 inspire some of the materials that I brought into the  
4 arena later. So, they were working with these warm  
5 colors, and I felt inspired, let's say, to bring that  
6 kind of sustainability in those wood products to the  
7 arena as well.

8           Very dynamic shape. It's difficult, honestly,  
9 to design a commercial building like this, and they've  
10 done a fantastic job, especially -- I think I mentioned  
11 this before -- with the side court location.

12           It optimizes the floor plates for the kinds of  
13 tenants that might be wanting to lease those spaces, but  
14 it is a difficult design challenge, and they've done a  
15 fantastic job on the exterior design of that building.

16           Here it is from a different angle. You're  
17 looking between the point where the commercial building  
18 and the arena almost touch each other. It can pass up  
19 into the main plaza from here, completing again your  
20 300-degree pedestrian walk around the site and around  
21 the arena.

22           This is the bike valet on the corner of  
23 southeast -- the southeast corner. So, we are on 16<sup>th</sup>  
24 Street looking towards the water here, and you can see  
25 the glass atrium of the southeast entrance lobby and the

1 pedestrian bike valet there on 16<sup>th</sup> Street.

2           For me, this is one of my favorite shots of  
3 the building, the shot of the southeast corner. Very,  
4 very dramatic. And again, a repeat of some of the  
5 things I've told you before with the updated materials,  
6 but the integrity and the impact of that view of the  
7 building remains unchanged.

8           Walking along TFB, you can see the building  
9 still sits on a podium of commercial retail areas --  
10 restaurants, cafes, all that open up to the park with  
11 street dining and operable walls.

12           It really improves the scale of the building  
13 here. We don't have to bring the building full height  
14 all the way down to the curb. It actually sits on a  
15 comfortable pedestrian-scale podium, the roof of which  
16 is absolutely accessible to the public 365 days a year.

17           And you can see that here. This is -- we're  
18 up at the pedestrian pathway level now. Our back is to  
19 the water. We're looking at what I call the tertiary  
20 entrance for the third -- the third-level entrance to  
21 the arena.

22           We can enter the main concourse of the  
23 building here even though it is not one of the main  
24 entrances of the building. We're allowing for that kind  
25 of access, and maybe more importantly, egress.

1           Walking around the building, we have an  
2 access-way or an elevator lobby to get up to the  
3 Bayfront Terrace from two areas of the site, one at TFB.  
4 Just off Terry Francois, we have an elevator lobby that  
5 takes you directly to the elevators that can access the  
6 Bayfront Terrace. Those elevators make a stop on the  
7 rooftop level of the commercial area and retail areas.  
8 Here you can see that shot there with the gateways in  
9 the background as you begin to walk around back towards  
10 the plaza.

11           And there you get a nice feeling of what that  
12 street feels like. Cafes and shops along the way. The  
13 gateways that break the wind and add a scale to it. And  
14 maybe even some twinkly lights that make it feel like an  
15 active space.

16           Another shot of it there.

17           So, one of the most significant changes we  
18 made to the exterior of the building was to introduce  
19 these light bands. Now, we, as a normal part -- again,  
20 a normal part of the development project, we had to  
21 optimize the side of the building.

22           We needed to reduce it as much as possible to  
23 reduce the girth of the building, the amount of surface  
24 area that we were actually building so it's smaller in  
25 girth than it was before.

1           It's like the difference between wearing a  
2 winter coat and a tight tee shirt. It's in a tight tee  
3 shirt now. The skin is as tight to the structure as we  
4 could make it, and that was important for two reasons.

5           First of all, it makes it more constructable,  
6 which is obviously important.

7           The other thing we had to do is we had to pull  
8 warpage out of the panels. So, a building that's shaped  
9 like this, it's very difficult to actually generate the  
10 geometry such that the panels don't have to bend in two  
11 directions. They can only bend in one direction.

12           So, we had to work with some sophisticated  
13 computer programs and some really smart engineers to  
14 redesign the exterior to where those panels were only  
15 bending in one direction. That's the only way it can be  
16 built.

17           Well, one of the ways we did that and one of  
18 the ways we also reduced the girth was to introduce  
19 these offsets in the facade. We're actually using those  
20 offsets as the potential for light bands that could --  
21 that could be -- that add more drama, frankly, to the  
22 exterior of the facade, especially during night.

23           And you can also see the punched pattern of  
24 perforation could also be articulated with light in some  
25 way. We're still working on the final details.

1           Here's another shot of the exterior southeast  
2 corner. Lobby entrance with the patterning in the  
3 metal.

4           The other thing I would say is we  
5 introduced -- on 16<sup>th</sup> Street, we introduced some  
6 windows. Before, that was a large, very blank facade.  
7 It was a little bit onerous for me. I knew we would get  
8 to it, but we just hadn't yet in the previous time that  
9 we met.

10           Since then, we've redesigned that facade of  
11 the building to include some light glass into the  
12 concourse, because it brings light into the concourses,  
13 but also at night, you can see it helps break down that  
14 facade to something that's a little more human scale and  
15 friendly to the street.

16           And then a quick shot of the interior of the  
17 building. Very few changes in the seating bowl area  
18 from what I might have presented before. Just again,  
19 further refinement.

20           This is a shot of the main entrance lobby off  
21 of the main plaza. So, we're just off 3rd Street -- I  
22 want to get you oriented here. Just off 3rd Street off  
23 the main plaza there, you walk in that large glass  
24 atrium and you see the entire building explode in front  
25 of you.

1           With a grand space, you can see the floor  
2 levels stacked above one another. Lots of excitement,  
3 lots of drama in that space.

4           And then the aerial with the City in the  
5 background. You've seen this before. Again, just  
6 updated for the current design.

7           And with that, I want to say thank you and  
8 pass the baton back to Sally. Thank you very much.

9           CHAIRPERSON ROSALES: Thank you.

10  
11           FURTHER PRESENTATION BY DEPUTY DIRECTOR OERTH

12  
13           DEPUTY DIRECTOR OERTH: Thank you, David.

14           So, as is typical with design approvals, this  
15 is a conditional approval. So, I'd like to just go over  
16 the conditions that are described to you in your  
17 memorandum and are incorporated into the resolution.

18           So, these conditions include, the project will  
19 comply with the MMRP and the improvement measures. It's  
20 contingent on the Event Center being approved as a  
21 secretary use.

22           The staff level -- staff will have approvals  
23 on various administrative variances on streetscape and  
24 infrastructure plans. So, we'll go through that  
25 process.

1           We've asked that on retail and restaurant  
2 spaces under 5,000 square feet -- that Notice of Special  
3 Restrictions be applied to those spaces to ensure that  
4 they stay those restaurant and retail spaces as we've  
5 planned.

6           We've requested certain additional detail  
7 design information as is typical as we go through the  
8 next level of design review.

9           We have asked that they submit a Project  
10 Signage Plan. That will come back before the Commission  
11 for you to review.

12           And we'd like to see some -- again, very  
13 typical -- some further refinements on certain elements  
14 of the design, including the retail frontages along  
15 Terry Francois Boulevard.

16           We've asked that they provide us with mock-ups  
17 of materials and colors as we move forward.

18           And then just noting that the project is, of  
19 course, required to pay any required Development Impact  
20 Fees, including but not limited to the Child Care Fee  
21 listed in the Redevelopment Plan, and the Transportation  
22 Impact Development Fee.

23           So, now turning to the Design for Development,  
24 or the D For D as we call it, design of all projects in  
25 Mission Bay South is regulated through the Mission Bay



1 South D For D document, and the project itself is  
2 consistent with the basic land use controls of the  
3 Redevelopment Plan, and is overall consistent with the  
4 design controls and design guidelines of the D For D.

5           However, staff is recommending that the D For  
6 D be amended to accommodate the specific characteristics  
7 of an event center and the related elements in the  
8 project.

9           To date, the D For D has been amended three  
10 times, so this would be the fourth amendment.

11           And so, the amendments related to this project  
12 would fall into the following categories listed for you  
13 there.

14           We would add relevant definitions of an "event  
15 center" and "events" in our project.

16           We would describe the height for the Event  
17 Center would be 135 feet, which is under the overall  
18 maximum of 160 feet for the project area.

19           You'll note there are two towers located on  
20 the site, so we're making that notation in the D For D  
21 to show that those two towers are located in this  
22 particular height zone of the Redevelopment Plan. We  
23 are allocating unused towers from elsewhere and showing  
24 it here.

25           We've also created a minimum tower separation

1 distance between the tower and the Event Center.

2 We're creating a bulk allowance for an event  
3 center, and we're adjusting the streetwall and setbacks  
4 to reflect the nature of the project with the plaza and  
5 the gatehouse, et cetera.

6 We've adjusted the definition of "view  
7 corridor." The design guidelines allow for view  
8 corridors to terminate in buildings that provide  
9 important architectural statements. And so, we're just  
10 noting that that is the case here with the Event Center  
11 as that important architectural moment.

12 And then we've included information related to  
13 the Event Center around parking ratios as well.

14 So, so far we've talked about the four  
15 resolutions that are before the Commission, and I'd also  
16 like to present information related to an action that  
17 would be taken by the Executive Director, and this is  
18 related to secondary land use determinations.

19 So, the Mission Bay South Redevelopment Plan  
20 lays out principal and secondary land uses, and the  
21 Redevelopment Plan delegates the authority for approval  
22 of secondary land uses to the Executive Director.

23 Past secondary uses -- secondary use approvals  
24 include those made for the U.C.S.F. Hospital and the  
25 Kaiser building.

1           The Event Center itself actually includes a  
2 variety of uses, including both principal and secondary  
3 uses. So, staff prepared an analysis of those secondary  
4 uses for the Executive Director's consideration, which  
5 was included in the information provided to the  
6 Commission.

7           So, I'll walk you through both the principal  
8 and secondary uses for the Event Center.

9           The principal uses include office use,  
10 accessory office space for the Golden State Warriors and  
11 meeting rooms; retail sales and services -- obviously,  
12 retail spaces and restaurants -- arts activities and art  
13 spaces, performing arts events, conventions of an  
14 artistic or cultural nature, other arts-related uses.  
15 Other uses include outdoor activities such as on the  
16 Bayfront Terrace.

17           And then the secondary uses of the Event  
18 Center fall under assembly and entertainment, including  
19 nighttime entertainment, a recreation building, and  
20 other uses such as a public structure and use of a  
21 non-industrial character.

22           So, staff has analyzed the secondary uses and  
23 has concluded that the secondary uses included in this  
24 project generally conform with the Redevelopment  
25 Objectives and Planning and Design Controls established

1 under the Redevelopment Plan, and are -- uses at this  
2 size and intensity contemplated and proposed at this  
3 location will provide a development that is necessary  
4 and desirable for and compatible with the neighborhood  
5 and the community. And therefore, staff is recommending  
6 that the Executive Director approve the Event Center as  
7 a secondary use.

8           So, under the Mission Bay South Owner  
9 Participation Agreement, the project must comply with  
10 OCII's SBE and Equal Opportunity Programs.

11           So, the project sponsor has been working  
12 closely with our Contract Compliance staff, and they've  
13 undertaken an extensive outreach and multi-stage  
14 solicitation effort in bringing on team members.

15           Approximately 95 percent of the disciplines  
16 needed for the project have been identified, and they  
17 are meeting the OCII goal of 50 percent SBE  
18 participation credit.

19           Actual SBE participation totals \$8.2 million  
20 to date, which 90 percent is committed to San Francisco  
21 SBE's.

22           In your packets, there was a break-out of all  
23 of the Professional Services SBE's with percentages  
24 there for you.

25           Moving forward, once they move into the

1 construction phase, they will have the 50 percent SBE  
2 subcontracting goal, and will also include a 50 percent  
3 local construction workforce hiring goal and, of course,  
4 the payment of prevailing wages.

5           And then, in the permanent stage, their  
6 permanent hiring would be done in accordance with the  
7 City's First Source Hiring Program.

8           So, now I'd like to just describe for you all  
9 of the various public outreach that we've undertaken  
10 along with our colleagues in the City as this project  
11 has been under review.

12           So, key stakeholder outreach includes  
13 neighborhood groups in Mission Bay, in Rincon, Potrero,  
14 Dogpatch, and other eastern neighborhoods; obviously  
15 U.C.S.F., Mission Bay, the San Francisco Giants, the  
16 Biotech Roundtable, the San Francisco Bicycle Coalition,  
17 Walk SF, and the Mission Bay Ballpark Transportation  
18 Coordination Committee; and, of course, our Citizens  
19 Advisory Committee, which we can't -- I can't do any  
20 projects without. And we thank them for their  
21 dedication and attention to this project as it's moved  
22 through the various stages.

23           But I'd like to also note some endorsements --  
24 some key endorsements that the project has received.

25           On October 6, U.C.S.F. endorsed the project.

1 On October 20<sup>th</sup>, we received a letter from the life  
2 sciences community endorsing the project.

3 I mentioned the CAC. We had about 10 meetings  
4 with the CAC over the last year, year and a half,  
5 including most recently on October 8th, we had a  
6 unanimous recommendation of the CAC to approve the  
7 project.

8 And I'd like to note another approval letter  
9 that is in your packets, this one from the Metropolitan  
10 Transportation Commission, or MTC. They have written a  
11 letter of support for the project. And again, that's in  
12 your packets, and copies are available for the public.

13 So, again, just to go over the different  
14 phases of review and actions that we've taken to date,  
15 under Environmental Review, again we started with an  
16 Initial Study and Notice of Preparation back in November  
17 of last year.

18 We published the EIR -- the Draft EIR in June  
19 of this year. We held a public hearing to accept oral  
20 comments on June 30<sup>th</sup>. The public comment period  
21 closed on July 27th. And then we published the  
22 Responses to Comments on October 23<sup>rd</sup>.

23 On the Project and Design Approvals, we have  
24 been before the Commission a number of times, including  
25 all the way back in April of 2014 when the Executive

1 Director provided a report to the Commission on the  
2 Warriors then proposed purchase of the site, which has  
3 since been completed.

4 In December of 2014, a presentation was made  
5 to the Planning Commission regarding the overall design.  
6 And then we came before you in January to talk through  
7 the major phase, and then again in May, as I mentioned,  
8 to do a Draft Schematic Design Workshop. Again, went  
9 back to the Planning Commission for that Schematic  
10 Design Workshop.

11 We went to the CAC October 8th.

12 And again, we're here before you today for the  
13 Environmental Impact Report certification, adoption of  
14 findings, and the D For D amendments, and the design  
15 approvals.

16 So, the next steps. The immediate next steps  
17 would be to accept public comment on the items I've just  
18 gone through, so we will do that.

19 The Commission will then consider the SEIR  
20 certification and adoption of the CEQA findings and  
21 MMRP.

22 You'll then consider other actions and hear  
23 from the Executive Director on secondary use.

24 And then after the project's Environmental  
25 Impact Report has been certified and the project

1   approvals have been made, the project will go before a  
2   variety of other public bodies.

3               As Adam mentioned, the project will go before  
4   the MTA's Board for their adoption of CEQA findings and  
5   resolution on applying the funds to the project that he  
6   described.

7               This week, on Thursday, the project goes  
8   before the Planning Commission. They have design review  
9   of office projects in Mission Bay as laid out in the  
10   Redevelopment Plan.

11              And then on Monday, November 9<sup>th</sup>, the  
12   Mission Bay Transportation Improvement Fund legislation  
13   goes before the Budget and Finance Committee of the  
14   Board of Supervisors.

15              And then a number of actions before the PUC,  
16   Port, and Entertainment Commission on November 10th.

17              And with that, that concludes staff's  
18   presentation, and we're available for any comments  
19   after -- or questions after public comment. Thank you.

20              CHAIRPERSON ROSALES: Thank you. That's a  
21   very thorough presentation.

22              So, before we entertain any questions, we need  
23   to take public comment.

24              Madam Secretary, do we have any -- I'm sure we  
25   have speaker cards, but can you tell me how many?



1 COMMISSION SECRETARY GUERRA: I can't tell you  
2 how many, but we have several -- a number of speaker  
3 cards.

4 CHAIRPERSON ROSALES: Okay.

5 Without objection by my fellow speakers, I'd  
6 like to limit the public comment to two minutes and see  
7 how we do.

8 So, can you please begin the calling of the  
9 members of the public, five names at a time?

10 COMMISSION SECRETARY GUERRA: Members of the  
11 public, I will call five names at a time. Please come  
12 to the podium in this order.

13 If you are in the Overflow Room 421, please  
14 make your way to Room 416 when I call your name.  
15 Members of public are asked to be seated in Overflow  
16 Room 421 after making public comments in order to  
17 provide space for the next speakers.

18 Brian Wiedenmeyer, Tom Lippe, Victor Parra,  
19 LeRoy Penny [sic], and Jim Lazarus.

20  
21 PUBLIC COMMENTS

22  
23 BRIAN WIEDENMEIER: Hi there, Commissioners.  
24 My name is Brian Wiedenmeier, and I'm here speaking on  
25 behalf of the San Francisco Bicycle Coalition.

1           We have been working with the Warriors closely  
2 over the last year to improve and refine the arena  
3 project's bicycle facilities and program. And I'm happy  
4 to say that after many months of discussions with the  
5 Warriors, SFMTA, and OEWD, we are pleased with the  
6 proposed bicycle and transportation designs, as well as  
7 bicycle safety and encouragement programs proposed with  
8 this project.

9           The significant bicycle improvements to  
10 Terry Francois Boulevard, 16<sup>th</sup> Street, and intersections  
11 in or around the arena site and the project's -- very  
12 important, the project's coordination with the expanding  
13 Bay Area Bike Share system, all make this a safe and  
14 comfortable destination to travel to and from by  
15 bicycle.

16           The event-based traffic management proposals  
17 are also strong, and with ongoing monitoring,  
18 evaluation, and adjustment, will help ensure the arena  
19 is a great place for people of all ages and incomes to  
20 bike to.

21           We're also thrilled to see the Warriors  
22 propose a large, dedicated space for bicycle valet  
23 parking that will accommodate the City's growing number  
24 of bike trips.

25           And speaking from experience, running the

1 bicycle valet parking at the Giants Stadium, which has  
2 150 spaces, we routinely have to turn people away. So,  
3 it's a very popular option.

4           The bike valet parking, along with the  
5 improved bike network and robust encouragement programs  
6 will help make this the single most bicycle-friendly  
7 professional sporting venue in the country upon  
8 completion. So, it could be a real feather in the  
9 City's cap.

10           We also acknowledge that the growing number of  
11 bicycle trips to a venue like this takes an ongoing  
12 effort over time, so we are looking forward to continued  
13 partnership with the Warriors to ensure this project and  
14 the City meet their goals to make this a great place to  
15 bike to.

16           Thank you.

17           CHAIRPERSON ROSALES: Thank you.

18           TOM LIPPE: Good morning, Members of the  
19 Commission. My name is Tom Lippe. I represent the  
20 Mission Bay Alliance.

21           And a couple of points. First of all, on the  
22 secondary use finding, Susan Brandt-Hawley, my  
23 cocounsel, has sent a letter by E-mail yesterday,  
24 contesting the secondary use -- the appropriateness of  
25 finding that this as an allowable secondary use under

1 the Redevelopment Plan. So, I would encourage you to  
2 take a look at that. She's also going to speak today to  
3 flesh out the reasons for that.

4 If it turns out that it is a proper secondary  
5 use, then you actually need a variance under the  
6 Redevelopment Plan. You can't just amend the Design for  
7 Development.

8 And I have a letter on that point, which I'd  
9 like to submit to you today, which I also E-mailed  
10 yesterday, and that is here.

11 (Letter submitted to staff.)

12 With respect to your finding that the EIR  
13 complies with CEQA, it turns out it doesn't for lots of  
14 reasons. One of those reasons has to do with the fact  
15 that the EIR took the position that compliance with the  
16 City's NPDES permit, which is a water-quality permit,  
17 would ensure no water-quality impacts of significance.

18 Well, I objected and said you have to prove  
19 that you comply. And the Response to Comments said,  
20 Well, we comply.

21 So, we got the Water Board enforcement files,  
22 which are five binders of ten years of noncompliance by  
23 the City. So, that simply is not a proper basis to find  
24 that there would be no significant effect on water  
25 quality. So, I'd like to give you those binders.

1 (Binders submitted to staff.)

2 There's also my comment letter on the EIR,  
3 which is in two binders, with Exhibits A through S.

4 (Binders submitted to staff.)

5 CHAIRPERSON ROSALES: So, is this the first  
6 time you're giving us this?

7 TOM LIPPE: It is.

8 And just on that point, we only had 11 days  
9 after your staff of 58 people had two months.

10 Two quick points. The Bay Area Air Quality  
11 Management District is not participating in your offset  
12 mitigation for ozone precursor pollution; therefore --

13 CHAIRPERSON ROSALES: Continue.

14 TOM LIPPE: -- that mitigation measure is no  
15 longer effective to reduce -- we never thought it was,  
16 but even on your own terms, it's not effective to reduce  
17 those impacts to less than significant, because the  
18 agency to do the offset program is no longer agreeing to  
19 the price.

20 And that is a mitigation measure that the  
21 project sponsor apparently has refused to adopt, and  
22 that's a trigger for recirculating the EIR as a draft so  
23 that people can comment on this development. And this  
24 is a development that occurred yesterday, apparently,  
25 based on the letter that was on the table this morning.

1           And then, finally, I have a letter from my  
2 co-counsel, Soluri Meserve, on the noncompliance of the  
3 EIR by CEQA.

4           (Letter submitted to staff.)

5           Thank you.

6           JIM LAZARUS: Commissioners, Jim Lazarus,  
7 San Francisco Chamber, also our partner in labor and  
8 other civic organizations, the Alliance for Jobs.

9           Our visitor economy will benefit greatly from  
10 this facility. This is a transit-rich location, one  
11 that can accommodate not only the great growth that we  
12 all appreciate at Mission Bay, but the growth of our  
13 visitor industry through the development of this  
14 facility.

15           I urge people to look at the ballot handbook  
16 from 1996, when the ballpark was on the ballot,  
17 challenged by early residents of Mission Bay and  
18 China Basin.

19           That ballpark said the world as we know it --  
20 or, that ballot argument said the world as we knew it at  
21 the time would end with the development of AT&T Park --  
22 congestion, driving jobs and tax revenues away from the  
23 City, gridlock -- opposed the ballpark. We know that  
24 didn't happen.

25           The privately built AT&T Park is one of the

1 great economic engines of San Francisco, and a privately  
2 developed arena at Mission Bay will do the same.

3 This is a site that can accommodate this  
4 public and privately -- jointly developed facility. And  
5 like other downtown facilities, it will have a  
6 tremendous impact on jobs and tax revenues to the City.

7 For decades, U.C.S.F. lived comfortably with  
8 Kezar Stadium down the hill, with college and high  
9 school and professional football in a 70,000-plus-seat  
10 stadium.

11 I'm sure that U.C.S.F. Mission Bay can live  
12 just as comfortably with this great Event Center a block  
13 or two away.

14 Thank you very much.

15 COMMISSION SECRETARY GUERRA: Victor Parra and  
16 LeRoy Penny [sic].

17 VICTOR PARRA: Good morning, Commissioners.  
18 My name is Victor Parra.

19 I'm the business manager at Laborers Local 67,  
20 Northern California, and the vice president of the  
21 San Francisco Building and Trades Council for  
22 San Francisco.

23 We're here to support and express the  
24 importance of having an arena to be built at  
25 Mission Bay.

1           We are extremely excited about the great jobs  
2 with great benefits and good, liveable wages that this  
3 arena will generate, or will create and, once again,  
4 give the San Franciscan community one more reason to be  
5 proud.

6           The Warriors have worked so hard at this and  
7 have done everything right, and I think it's just  
8 possible that we get all the support that they need.

9           And I'm here to let you know that we are  
10 extremely frustrated with the Mission Bay Alliance, who  
11 has been an obstacle obstructing this great project that  
12 has so much support.

13           Thank you very much.

14           CHAIRPERSON ROSALES: Thank you.

15           COMMISSION SECRETARY GUERRA: Can the  
16 following people please come up: Pete Varma, David  
17 De La Torre, Lori Yamauchi, Corinne Woods, and  
18 Cathy Scarby [sic].

19           PETE VARMA: Good morning, Commissioners.

20           CHAIRPERSON ROSALES: Good morning.

21           PETE VARMA: My name is Pete Varma, and I'm  
22 here representing National Association of Minority  
23 Contractors and Suppliers.

24           We are a Northern California chapter. The  
25 Association is a national organization that provides



1 subcontracting opportunity to minority contractors and  
2 suppliers.

3           Having built numerous projects in the Bay Area  
4 and now this particular project, we welcome that this  
5 project would provide a lot of subcontracting  
6 opportunities for minority contractors and suppliers.  
7 It will create jobs in the community.

8           This is an excellent project for Bay Area to  
9 have a stadium right in their backyard, and we support  
10 that the Commissioners will look forward to approving  
11 this.

12           Thank you.

13           CHAIRPERSON ROSALES: Thank you.

14           LEROY PERRY: Good morning, Commissioners. My  
15 name is LeRoy Perry. I am an 18-year resident in the  
16 Dogpatch community.

17           There's a lot of wonderful things going on in  
18 the Dogpatch community, and this right here is another  
19 addition to it.

20           This right here would bring more than just  
21 jobs. It will bring comfort. It will bring comfort to  
22 the parents that don't have anyplace to take the kids in  
23 the afternoon, kids that want something to do  
24 positively -- enjoyment for everyone in the family to  
25 do.

1           The neighborhood is definitely coming up and  
2     developing well, and I ask that all of you endorse this.

3           Thank you very much.

4           CHAIRPERSON ROSALES: Thank you.

5           LORI YAMAUCHI: Good morning, Commissioners.  
6     Lori Yamauchi, Associate Vice Chancellor, Campus  
7     Planning, U.C.S.F.

8           On behalf of U.C.S.F., I wish to express the  
9     University's support for the Golden State Warriors Event  
10    Center Project. I'm submitting a letter for your review  
11    and consideration, highlighting the key points of that  
12    letter in my oral remarks.

13           (Letter submitted to staff.)

14           Since the Warriors announced its intent to  
15    build a new Event Center complex at Mission Bay,  
16    U.C.S.F. has expressed its concerns about the impacts of  
17    the proposed project on traffic and parking in the area,  
18    with particular focus on the effects on patient safety.

19           We reviewed and commented on multiple  
20    documents issued by the City, as well as participated in  
21    numerous meetings and testified before this body in the  
22    Planning Commission. We submitted a comment letter on  
23    the Draft SEIR. And after review of the Final SEIR, we  
24    concluded that the City's responses to our comments are  
25    generally satisfactory.

1           We appreciate the addition of a Local Hospital  
2 Access Plan to the Transportation Management Plan for  
3 the project. We also appreciate the proposed off-site  
4 parking to the south of the Event Center for use by  
5 event attendees, namely the 19<sup>th</sup> Street lot at Pier 70  
6 and the rest of the pier site near Pier 80.

7           And we wish to reiterate that U.C.S.F. is  
8 unable to make its off-street parking garages and lots  
9 available to event attendees, because U.C.S.F. needs  
10 this parking to meet the demands of staff, patients, and  
11 visitors.

12           We also appreciate the proposed Mission Bay  
13 Transportation Improvement Fund, including the  
14 Designated Overlapping Event Reserve Account to fund  
15 traffic management programs implemented by the City to  
16 serve the project.

17           We also appreciate the proposed formation of  
18 an Advisory Committee which would include U.C.S.F.

19           We appreciate the refinements in the  
20 construction plan and the proposed Muni/U.C.S.F.  
21 Mission Bay station variant, recommending that the OCII  
22 Commission adopt that variant as part of the project  
23 approval.

24           A few areas where we believe the Final SEIR  
25 and project could be strengthened include the City

1 making long-term commitments on providing off-site  
2 parking, and asking that the City provide a solution to  
3 the traffic congestion at Mariposa I-280 off-ramp, and  
4 produce an explanation of how this wastewater treatment  
5 capacity in Mission Bay will be made adequate to serve  
6 all protected development in Mission Bay.

7 Thank you for consideration to my written and  
8 oral comments.

9 CHAIRPERSON ROSALES: Thank you very much.

10 DAVID DE LA TORRE: Good morning,  
11 Commissioners. David De La Torre, Laborers Local 261.

12 I'm here on behalf of both Laborers Local 261  
13 and the A. Philip Randolph Institute San Francisco  
14 chapter of which I am the chairperson.

15 I'm here to voice our support in moving  
16 forward with this project because of the commitment to  
17 building it with union labor, securing the area's  
18 standard and community involvement.

19 So, I strongly encourage the approval of the  
20 EIR report and moving one step closer to finally getting  
21 this project built, and to flourish.

22 Thank you.

23 CHAIRPERSON ROSALES: Thank you.

24 COMMISSION SECRETARY GUERRA: Can the  
25 following people please come forward: Ramon Hernandez.

1 CATHY SEARBY: Good morning. My name is Cathy  
2 Searby and I live in Mission Bay. The proposed arena  
3 site is directly next to my home.

4 I am so excited, not only to watch the  
5 Warriors play basketball at the arena, but to have  
6 concerts and family shows like Disney on Ice, Harlem  
7 Globetrotters, that we all can attend -- San Francisco  
8 needs this kind of arena to be a first-class  
9 entertainment destination.

10 I'm also excited about the waterfront park, as  
11 there's nothing in this community in the south  
12 neighborhoods. It provides a place for the kids and the  
13 families to enjoy the beautiful views in a fun and safe  
14 environment.

15 The Warriors and the City have done an  
16 impressive study of this project, and as a result,  
17 they've come up with a project that fits well in our  
18 Mission Bay community.

19 Thank you.

20 CHAIRPERSON ROSALES: Thank you.

21 CORINNE WOODS: Good morning, Commissioners.  
22 My name is Corinne Woods.

23 I chair the Mission Bay Citizens Advisory  
24 Committee, which has unanimously approved a Schematic  
25 Design Plan for the arena.

1 I'm also representing the Mission Bay CAC on  
2 the ballpark, Mission Bay Transportation Coordinating  
3 Committee, where I've worked for at least 10 years -- I  
4 don't know how long -- to try and deal with the existing  
5 traffic and transportation implications of both Mission  
6 Bay and the ballpark.

7 To me, approval of this EIR is the first step,  
8 and it's all about implementation. It's all about  
9 making sure that we don't get forgotten once the  
10 approvals go through.

11 There are some inconsistencies between the  
12 requirements of the EIR, in terms of traffic and  
13 transportation mitigations and improvements, and the  
14 legislation that's moving through both the MTA and the  
15 Board of Supervisors in terms of how it's going to be  
16 managed.

17 OCII is the responsible agency for this  
18 project. OCII has taken a very low-key approach to  
19 Mission Bay over the years. And, in fact, the last  
20 couple of years, we've been starved for staff help and  
21 support, as Tiffany knows.

22 We need dedication. Even if you can delegate  
23 these approvals and monitoring and everything else, we  
24 need you, OCII, to make sure things happen, because they  
25 won't happen if it's up to just this agency or that

1 agency that you delegate to.

2 It took us 15 years to get a bus in  
3 Mission Bay that was promised to us in 2003. We still  
4 have streets that are open -- that are finished and not  
5 open, parks that are finished and not open.

6 We need OCII to take a very much more  
7 aggressive approach to managing the process so that we  
8 can survive this.

9 Thank you.

10 CHAIRPERSON ROSALES: Thank you.

11 COMMISSION SECRETARY GUERRA: Ramon Hernandez,  
12 Matt Prieshoff, Thomas McDonagh, David Lombardi, and  
13 Scott Van Horn, please make your way to the podium.

14 DAVID LOMBARDI: Good morning. My name is  
15 David Lombardi, and I'm coming here in support of the  
16 Warriors Arena Project.

17 First off, as a resident of San Francisco --  
18 haven't always lived here -- but I live in the Mission  
19 now, and I remember visiting from about three hours  
20 away, when I was about 10 years old, back in 1998.

21 My dad drove me to the area near 3<sup>rd</sup> and King  
22 Streets, where AT&T Park would once be. It was  
23 desolate, abandoned. Definitely not a source of pride  
24 for what I think is the most beautiful city in America.

25 And my dad told me that the Giants are going

1 to be playing here, Barry Bonds is going to be hitting  
2 home runs here in three years or four years. I didn't  
3 believe him. As a young sports fan, it just blew my  
4 mind.

5 And now we look 18 years later, we see what  
6 that area has become, what it's becoming, and what kind  
7 of boon that has been for the City.

8 I see this Warriors Project in much the same  
9 way, although I think Mission Bay is a little bit more  
10 developed, obviously, already than that whole South  
11 Beach area was when AT&T Park was proposed. I think  
12 that we can see similar benefits from this from the  
13 perspective of the City.

14 Second, not as a resident, but as a person who  
15 covers sports, I work for ESPN, and I cover college  
16 football. I've covered a bunch of other sports. I've  
17 traveled a lot, and I've seen different venues around  
18 the country. It's just part of my job every weekend,  
19 and I see which ones fit into the fabric of a city and  
20 which ones I'm not excited to go to.

21 I can say that AT&T Park has been a major  
22 success in that regard, and based on the plans that I've  
23 seen today and I've studied from this Warriors proposal,  
24 I think that this one will fit perfectly into the urban  
25 fabric of San Francisco in a way that will improve the



1 City.

2           You just can't be taken seriously as a major  
3 city in the world without a venue like this, and I think  
4 that will fill the void. So, I encourage you guys to  
5 approve it.

6           Thank you.

7           CHAIRPERSON ROSALES: Thank you.

8           THOMAS McDONAGH: Good morning, Commissioners  
9 and thank you for this opportunity. My name is  
10 Thomas McDonagh.

11           I live, work, and have a small business in  
12 San Francisco. I've been a resident of the City since  
13 the 1970s, and I have lived South of Market for 15 years  
14 plus.

15           I've witnessed the difference the construction  
16 of the ballpark brought to the neighborhood in 2000, and  
17 it helped to reignite the development of the  
18 neighborhood since then. The Golden State Warriors will  
19 help reignite the neighborhood and the City and the  
20 region with this development.

21           Sports plays a large role in our society. It  
22 teaches people enduring values such as teamwork and  
23 sportsmanship.

24           This venture will stimulate the economy.  
25 Tourism and entertainment are a major part of

1 San Francisco's economy. By building the arena in  
2 Mission Bay, San Francisco would be positioned to put on  
3 world-class performances to larger audiences.

4 Thank you.

5 MATT PRIESHOFF: Good afternoon. My name is  
6 Matt Prieshoff.

7 I'm the chief operating officer for  
8 Live Nation in the State of California.

9 Anaheim, Bakersfield, Carson, Fresno, Long  
10 Beach, Redding, Oakland, Ontario, San Jose, Sacramento,  
11 Los Angeles times two, San Diego times two, and  
12 Stockton -- they all have arenas. We don't in  
13 San Francisco. Our best opportunity in history to have  
14 a world-class arena is now, because of the Golden State  
15 Warriors.

16 They've done a phenomenal job creating an EIR,  
17 with the City's help, that addresses all of the concerns  
18 that have been raised.

19 Our office in San Francisco is at 16<sup>th</sup> and  
20 Rhode Island, so we have great familiarity with this  
21 location. We know what the traffic concerns are, and we  
22 know that they've been addressed by the plans that have  
23 been put in place by this EIR.

24 This organization has done a phenomenal job  
25 reaching out to the community and will continue to do so

1 for its entire history in San Francisco if given the  
2 opportunity to bring this arena to San Francisco.

3 And if they do, Live Nation will provide many  
4 great entertainment concerts and other events to this  
5 amazing city that currently you have to go to Oakland  
6 and San Jose because of the lack of an arena in  
7 San Francisco.

8 Thank you very much for your time.

9 CHAIRPERSON ROSALES: Thank you.

10 COMMISSION SECRETARY GUERRA: Would the  
11 following individuals please come forward:  
12 Henry Wimmer, Anthony Urbina, John Ballesteros,  
13 Mike Therault, and Nina Ladow.

14 SCOTT VAN HORN: Hi. Scott Van Horn. Thank  
15 you for the chance to speak to you today.

16 I live and work in Dogpatch, just two blocks  
17 from the site. I can actually see the site from my  
18 unit. When I addressed this Commission in June, I  
19 stated that I fully support the project, and I still do.

20 Today, however, I want to address the EIR  
21 process and those that are attempting to undermine it,  
22 specifically, the Mission Bay Alliance.

23 Since they were formed at the beginning of  
24 May, they have been saying that they will do everything  
25 they can to stop this project. Instead of participating

1 in the City and State processes that fully analyze the  
2 impact to the environment and to the community, they  
3 have been planning from the beginning to use their  
4 considerable wealth to litigate this forever.

5 I was even at the Mission Bay community  
6 meeting on May 7<sup>th</sup>, when Jack Davis said that they  
7 would, quote, sue until the cows come home.

8 The Warriors have worked with the community  
9 from the beginning. They have worked with the MTA to  
10 ensure that there will be massive improvements to Muni  
11 to put in place for everyone to use. There will be  
12 improvements to waterfront parks that will benefit  
13 everybody. They even worked with the City to put aside  
14 a reserve fund for the unexpected issues.

15 As you can see from these articles that I'd  
16 like to submit, they did not even wait for the Draft EIR  
17 to be published before they just started to attack it,  
18 at least what they assumed would be in it. This  
19 includes the Matier & Ross article on May 4<sup>th</sup>, where  
20 they make it clear that they will not be funding an  
21 effort that would benefit the community in any way, but  
22 instead, these billionaires want the land for  
23 themselves. They want to throw away all the  
24 improvements that will happen with this project so they  
25 can build their own selves, leaving the community out in

1 the cold.

2 I urge you to approve this EIR so that we can  
3 see the massive benefits to my neighborhood and to the  
4 City. I also hope to see the Warriors bring another  
5 championship to San Francisco.

6 Thank you.

7 CHAIRPERSON ROSALES: Thank you.

8 HENRY WIMMER: Good morning, Commissioners.  
9 My name is Henry Wimmer.

10 I've lived in the City 27 years. I'm a  
11 resident of Potrero Hill, small business owner since  
12 1994, and I just wanted to speak on a number of terms,  
13 but I'll be brief.

14 I wanted to commend the Warriors for their  
15 outreach in the community. I've been part of a number  
16 of neighborhood meetings that have addressed a lot of  
17 concerns with neighbors, including transportational  
18 issues and educational opportunities for the 3<sup>rd</sup> Street  
19 corridor and development of the area.

20 I'm very much in favor of the project, and I'm  
21 excited about the design of the arena as well. I think  
22 the open space -- 30 percent of the protected project  
23 allocated to open space with the open plaza and being  
24 able to 360 degrees around the arena and the lakefront  
25 -- bayfront area is really substantial and noteworthy.

1 I think it provides a lot of opportunity for  
2 the citizens of the City and others who come visit our  
3 great City to enjoy the lakefront and the opportunities  
4 of retail and business in the area. I think it will  
5 stimulate the economy.

6 I think it's really, really a beautiful  
7 design. And I'll keep it brief and just say I'm very  
8 much in favor of the project.

9 Thank you so much.

10 CHAIRPERSON ROSALES: Thank you.

11 ANTHONY URBINA: Good morning. My name is  
12 Anthony Urbina.

13 I'm a business representative in the Sheet  
14 Metal Workers Union Local 104.

15 Local 104, we're also affiliates with the  
16 San Francisco Building Trades Council and members of the  
17 San Francisco Alliance for Jobs and Sustainable Growth.  
18 I'm here to express the strong support for the Warriors  
19 Arena.

20 Organized labor has fought hard to see that  
21 this project happens. We're frustrated by the efforts  
22 of the Mission Bay Alliance that is now funding  
23 opposition to the project, a project that has so much  
24 community support.

25 The Warriors have worked hard with the

1 community, and they have worked with labor. This  
2 project will bring good career pathways for  
3 San Francisco youth, opportunities to become  
4 state-certified apprentices. It will bring good jobs  
5 with living wages and benefits to thousands of workers.

6 The Warriors Arena will be added to a long  
7 list of great San Francisco projects that have provided  
8 opportunity, employment, and entertainment.

9 Please support this project.

10 Thank you.

11 NINA LADOW: Good morning, Commissioners. I'm  
12 Nina Ladow.

13 I'm a longtime resident of Potrero Hill. I  
14 have been there 24 years. I'm an active community  
15 volunteer.

16 What I see, what the Warriors have done and  
17 what they're committed to is to help the underserved of  
18 our community have an opportunity for education and  
19 training, particularly through the trades, and then  
20 those jobs can translate into other jobs as they move on  
21 through their careers.

22 I commend the Warriors for their plan. I can  
23 see from my house -- I'm by Mariposa and the on-ramps,  
24 so I know the traffic congestion.

25 I also commend the effort that has gone into

1 the traffic mitigation.

2 I urge you in all sincerity to approve this  
3 project and help our community and the Warriors succeed.

4 CHAIRPERSON ROSALES: Thank you.

5 MIKE THERAULT: Commissioners, Mike Therault,  
6 San Francisco Building and Construction Trades Council.

7 We were thrilled to read about the agreement  
8 between U.C.S.F. and the Warriors with regard to this  
9 arena.

10 U.C.S.F. is an institution we certainly  
11 respect, and its landing in Mission Bay, you will all  
12 recall, through the deal that was brokered by Mayor  
13 Brown was what allowed that redevelopment finally to  
14 proceed in a meaningful way.

15 We're not surprised by the agreement. Our own  
16 dealings with the Warriors in our ongoing discussions to  
17 refine our agreements with them have shown them to be  
18 both cooperative and pragmatic.

19 With regard to the issue raised by the  
20 Mission Bay Alliance of water quality, you may also  
21 recall that about 10 years ago, Chevron did substantial  
22 remediation of that site, excavating it to a depth of  
23 about 20 feet and removing a groundwater plume of  
24 hydrocarbons to bring the water up to standards. That  
25 water has been taken care of already.



1           And I will point out, also, that all of you  
2 know that we're entrusted with jobs in construction and  
3 the opportunities they provide to the community.

4           Mr. Lazarus is correct, also, in pointing out  
5 that this is an ongoing economic boon to the City and a  
6 continuing source of opportunity for residents of  
7 San Francisco in other types of employment as well.

8           We ask you to approve the Environmental Impact  
9 Report and to carry on with the other approvals before  
10 you today.

11           Thank you.

12           CHAIRPERSON ROSALES: Thank you.

13           COMMISSION SECRETARY GUERRA: Will the  
14 following people please come forward: Chris Keller,  
15 Charlie Lavery, Joel Koppel, Antoinette Mobley, and  
16 David Wong.

17           JON BALLESTEROS: Good morning, Commissioners.  
18 Jon Ballesteros with San Francisco Travel.

19           And San Francisco Travel remains an  
20 enthusiastic supporter of this project, as it will add a  
21 dimension that's really needed here in San Francisco, a  
22 dimension to the \$10.7 billion travel and tourism  
23 industry here in the City. And that new dimension is a  
24 large venue that can accommodate many of the special  
25 events and programs that we currently cannot

1 accommodate.

2 And if this project is approved and we are  
3 able to accommodate those special projects and programs,  
4 it will expand the benefits of travel and tourism to the  
5 City. And these include creating more jobs,  
6 contributing more taxes to the City's General Fund, and  
7 expanding the overall economic activity here in  
8 San Francisco.

9 So, for these reasons, we encourage your  
10 Commission to approve the EIR that's before you today  
11 and move this important and valuable project forward as  
12 soon as possible.

13 Thank you for your time.

14 CHAIRPERSON ROSALES: Thank you.

15 CHRIS KELLER: Hello, Commissioners. My name  
16 is Chris Keller.

17 I live in Los Altos and was previously a  
18 commissioner for the environmental commission in that  
19 city, and I want to thank you for all the work that you  
20 do.

21 I am currently between jobs, full-time  
22 employment, so I've been driving with Uber and Lyft  
23 lately. I am not here representing either organization,  
24 but just want to add that, to the extent that there are  
25 those that jobs will be created through this new park, I

1 think there are other opportunities for some of these  
2 new technologies to also fill in, as needed, in an  
3 appropriate way, to provide meaningful income for other  
4 members of the community.

5 I just also want to say, you know, during my  
6 time as an environmental commissioner, no EIR comes in  
7 perfect, certainly not one at this scale. Five binders  
8 do not change that.

9 But I think that what you'll find, as I have  
10 seen over the last few years, is that Rick Welts and his  
11 team -- it's a world-class organization, not just in  
12 professional sports but in -- throughout -- anywhere in  
13 our community, willing to work hand in hand with so many  
14 people to do the right thing.

15 Lastly, I just want to say that I have four  
16 daughters. And, you know, raising kids is all about  
17 creating family memories.

18 One of the most meaningful moments I have in  
19 my life right now is to watch these games with my kids.  
20 And to think about coming to this venue with them will  
21 certainly qualify as a memory for me and my children.

22 Thank you.

23 CHAIRPERSON ROSALES: Thank you.

24 CHARLEY LAVERY: Good morning, Commissioners.  
25 My name is Charley Lavery.

1 I'm the district representative for the  
2 Operating Engineers Union Local 3. I'm also the chair  
3 of the labor caucus of the San Francisco Alliance for  
4 Jobs and Sustainable Growth, and both of those  
5 organizations want to express their support for the  
6 Warriors Project.

7 The Operating Engineers, through the  
8 San Francisco Building Trades Council, have been  
9 discussing with the Warriors how we can best work  
10 together.

11 The result, so far, is a commitment to work  
12 with labor to maximize opportunities for San Francisco  
13 residents to have living-wage jobs with benefits on the  
14 project.

15 Those residents in the trades need a sustained  
16 stream of projects to remain employed. Despite the  
17 building we see around the City, it's important to  
18 remember that each time a building is completed, those  
19 trades-workers are effectively unemployed again.

20 The Warriors have really been the poster child  
21 for outreach, both with the building trades and with the  
22 communities through their CBO's within the City where we  
23 live.

24 This is a great opportunity for our members to  
25 work on a project that will provide the City with a

1 much-needed amenity, and that improves the City and  
2 enhances their career opportunities.

3 Thank you.

4 ANTOINETTE MOBLEY: Go Warriors.

5 Good morning. My name is Antoinette Mobley.

6 I'm a resident of Bayview-Hunters Point, and I  
7 want to thank you Commissioners for being here to take  
8 in all the considerations to approve the EIR report.

9 The Warriors ground, this new event center,  
10 it's just -- it's just been long coming. It's long  
11 overdue.

12 I mean, in the evening time and on weekends,  
13 there's very little to do here in our neighborhood. And  
14 even though, with the emerging businesses that have come  
15 along in the Dogpatch area, which we really appreciate,  
16 it's kind of for grown folks, you know, not for the  
17 kids. So, this is an opportunity for our families to  
18 get out and bike and enjoy the great outdoors.

19 You know, I'm a staff member of Recreation and  
20 Park here at San Francisco, so I really, really advocate  
21 for the outdoors. And to be able to bring something  
22 along the waterfront -- we can walk here, we can bike  
23 here -- it's just the greatest amenity one could ask for  
24 in such a world-class city.

25 And then I also want to add to that in terms

1 of their plans for transportation, honey, you couldn't  
2 come up with a better plan.

3 I take that T Train sometimes on those Giants  
4 days, and I can't get home; okay. Takes me an hour,  
5 where it would take maybe 15 minutes. So, I'm thankful  
6 that they thought about that, because they took the time  
7 to come in the community and ask us, What are the pros?  
8 What are the cons? How can we make this thing right for  
9 everybody? And they did that.

10 So, I really want to thank the Warriors team  
11 for being such a great community partner. I'm  
12 really looking forward -- oh, the Warriors tore Memphis  
13 up last night. Did you all see that game? 50 points.  
14 Come on. That is world-class.

15 So, again, I encourage you guys, support this.  
16 The businesses on 3<sup>rd</sup> Street in the southeast sector, we  
17 need this. We need the foot traffic to come into the  
18 corridors to help support, to help sustain those who  
19 have been here; okay?

20 So, go Giants -- I'm sorry. Go Warriors.

21 JOEL KOPPEL: Good morning, Commissioners.  
22 I'm Joel Koppel.

23 I'm a Local 6 electrical worker that lives in  
24 the Sunset. I grew up here, went to school here, went  
25 to high school, college. I was lucky enough to buy a

1 home in the Sunset with my sister.

2 I'm here speaking today for the San Francisco  
3 Electrical Contractors Association and the Electrical  
4 Workers Local 6.

5 Both sides of our industry are very much in  
6 favor of certifying the Final SEIR today and moving the  
7 project ahead as proposed.

8 We have 32 local business enterprises in  
9 San Francisco that are in favor of this project, that  
10 pay their payroll taxes and gross receipts taxes here in  
11 San Francisco. And we have 794 San Francisco resident  
12 electrician journeymen and apprentices that are employed  
13 by these contractors.

14 So, not just as a laborer here today  
15 supporting, as you've heard from the other brothers and  
16 sisters of the other unions, but also, management is  
17 here also in full support the project.

18 Thank you.

19 CHAIRPERSON ROSALES: Thank you.

20 COMMISSION SECRETARY GUERRA: Can the  
21 following people please make it to the podium: Ramon  
22 Hernandez, John William Templeton, Pat Valentino,  
23 Stuart Canning, D.J. Brookter, and Donald Dewsnud.

24 DAVID WONG: Dear Commissioners, good morning.  
25 Thanks for your time, and thanks for allowing us to be

1 here to ask for your support.

2 I'm David Wong. I'm Bay Area Deputy Sheriff  
3 Charitable Foundation executive director. We work with  
4 you, and once a year, we have a shop with the Deputy  
5 Sheriff program where we take 300 to 500 disadvantaged  
6 children to do Christmas shopping. And out of those --  
7 out of that program, we ask a pro sport athlete to  
8 accompany -- to do the shopping, where we guide the kids  
9 to a better direction.

10 I'm a retired Deputy sheriff in San Francisco,  
11 and if we can prevent kids when they're young, we can  
12 prevent a lot of crime. And that's what I do.

13 So, just imagine when Coach Al Attles,  
14 accompanied with a couple of kids to shop, their parent  
15 is so amazingly shocked that, you know, Coach Al Attles  
16 would shop with them.

17 Just imagine if we could tell the parents and  
18 the children that Warriors is -- their home is with us.  
19 And that will be world-class decision. And I hope you  
20 can make that world-class decision.

21 Thank you.

22 JOHN WILLIAM TEMPLETON: John William  
23 Templeton. I'm historian and creator of the California:  
24 "African American Freedom Trail."

25 The Subsequent EIR violates, procedurally and



1 substantively, every tenet of California's pioneering  
2 Environmental Justice Law and a 1994 federal executive  
3 order.

4 I've submitted a 40-page document that spells  
5 out the many ways that the characterization of impacts  
6 fails to take into account the cumulative effects of 70  
7 years of land use inequity.

8 When I heard Planning Commissioner Ed Maley's  
9 (phonetic) objectionable remarks last week, I conducted  
10 a critical race theory analysis of this EIR to see that  
11 it substantially -- in trying to assemble this into a  
12 document, that certain groups of people are more  
13 valuable than others -- this measure breaks a covenant  
14 with the people of southeast San Francisco that \$2.2  
15 billion spent on their T Lines would link them to the  
16 rest of the City, and negatively impacts them for a  
17 generation to come.

18 In 1951, U.C.S.F. had the opportunity to play  
19 in the Cotton Bowl with the condition that they had to  
20 leave their black players behind. They turned down the  
21 invitation.

22 We shouldn't leave our impacted communities  
23 behind in order to approve this ill-conceived project.

24 CHAIRPERSON ROSALES: Thank you.

25 PAT VALENTINO: Good afternoon -- good

1 morning. My name is Pat Valentino.

2 I'm the president of the South  
3 Beach/Mission Bay Merchants Association. We're in full  
4 support of this project and ask you to certify the EIR  
5 as soon as possible.

6 Mission Bay needs a sense of place, and I  
7 think the way we pictured it is, when there are no  
8 events and there are no games, this facility is going to  
9 be extremely valuable to our neighborhood.

10 I not only am the president of that  
11 organization, I also live within walking distance of the  
12 Warriors site. And we're super excited, both as  
13 neighbors and business folks in the community.

14 I think one of the things, though, that's  
15 really important to think about, we've heard one point  
16 of opposition today. We have a diverse community in  
17 support of this project.

18 The comments that have come in, in support  
19 range across business local merchants, community groups,  
20 residents, neighbors, and folks from around the region  
21 and around the City, versus paid consultants, paid legal  
22 advisers who come here and give you binders full of  
23 garbage to basically throw mud against the wall.

24 And as one of the residents from Dogpatch  
25 neighborhood mentioned earlier, these guys, the

1 Mission Bay Alliance, came forward prior to the public  
2 having access to this EIR and started to make comments  
3 about suing till the cows come home.

4 I've been practicing law for over 20 years,  
5 and I can tell you one thing that I always tell my  
6 clients. When someone says they're going to sue you,  
7 and they're going to hire the most expensive lawyers,  
8 and they're going to sue till the cows come home, they  
9 have no case. And what we have here is no case against  
10 an incredible amount of community support.

11 So, I think you've heard quite a few of the  
12 good, positive comments. So, I'll just finish with  
13 saying, thanks so much, and thanks to the Warriors for  
14 participating with the City in a very community-oriented  
15 process. We look forward to you coming to  
16 San Francisco.

17 Thank you.

18 CHAIRPERSON ROSALES: Thank you.

19 COMMISSION SECRETARY GUERRA: Will the  
20 following people please come to the podium: Nick  
21 Belloni, Henry Karnilowicz -- sorry if I mispronounced  
22 it -- John Caine, Oscar James, and Dennis MacKenzie.

23 DONALD DEWSNUD: Good afternoon,  
24 Commissioners. My name is Donald Dews nud, and I'm a  
25 resident here in the City of San Francisco.

1 I'm very active in the community as a  
2 San Francisco Bay Area Renters Federation member, as  
3 well as a Sierra Club member here in the City.

4 However, I'm speaking for myself today  
5 concerning this project, and I urge you to please  
6 support it, because quite frankly, I'm very unhappy with  
7 our right-wing NIMBY's here in our City trying to  
8 prevent any sort of progress or development to take a  
9 dead block that's a field of dirt and make it into  
10 something that could be a center for the neighborhood,  
11 for the community, with this event venue.

12 As far as providing more jobs, about 600 of  
13 them, with our corporate square footage, and also, more  
14 importantly, on the retail space down below on the first  
15 floor, that is an opportunity for Dogpatch small  
16 business owners to have their business there at the  
17 plaza.

18 Also, too, I want to speak concerning the open  
19 space. It's -- this project has 33-percent open space  
20 of 3.2 acres.

21 There are parking concerns. However, we do  
22 have that Safeway garage over there off of King Street.  
23 We do have the AT&T Ballpark garage, as well, to rely  
24 on. So, we have plenty of ample opportunities for  
25 parking spaces around.

1           Also, too, I want to point out that this  
2 particular project contributes \$18 million to  
3 infrastructure fees to the City, as well as \$40 million  
4 towards the transportation of the infrastructure system  
5 as well.

6           So, again, thank you for hearing me out, and  
7 thank you for all your hard work. Please support this  
8 project.

9           Thank you.

10          NICK BELLONI: Good morning, Commissioners.  
11 My name is Nick Belloni, and I want to thank you for  
12 having us here today.

13          I'm excited to basically welcome the Warriors  
14 here to San Francisco. I'm supporting the project  
15 because there is a lot of reasons.

16          One, the arena will be built on private  
17 property land that's been planned for development for  
18 years.

19          Two, the development is highly -- entirely  
20 privately financed, without any public funding, which is  
21 a huge demonstration of the team's commitment to the  
22 neighborhood, which I've seen throughout the process.

23          I've been part of this since the beginning of  
24 them coming, and I've just seen them work tirelessly  
25 with the communities -- work and change.

1           And, I mean, they've basically been one of the  
2 best developers I've worked with. And being the co-VP  
3 of PAR, I've worked with a lot of different developers.  
4 So, it's been great to see that.

5           They also will be -- the new arena is a  
6 perfect fit for Mission Bay, and it will trigger the  
7 construction of a long-awaited five-and-a-half-acre park  
8 in Mission Bay.

9           This is something that is personal to me as  
10 well. I am a representative of the Park Rec Open Space  
11 Advisory Committee, and one of the things I've been  
12 pushing for for a long time on that committee is getting  
13 open space in that area.

14           So, this is something that I just pushed a  
15 strategic plan for that area to the Commission to get --  
16 that we can have a strategic plan for the area to have  
17 open space, to find places.

18           This is a perfect spot for it, and they're  
19 adding that in there. And that's something that's  
20 major.

21           And it's a waterfront park, something we don't  
22 have -- that we don't have a lot of, I should say. So,  
23 this is huge.

24           The site also has excellent freeway access,  
25 benefits from the infrastructure underway, including

1 construction of new off-ramps, a network of  
2 high-capacity streets, intersections, improvements in  
3 more than 9,000 public parking spaces already in place.

4 So, I want to thank you guys for hearing me.  
5 I want to thank you guys for having this, and I hope you  
6 all vote to have them here.

7 Thank you, guys.

8 CHAIRPERSON ROSALES: Thank you.

9 HENRY KARNILOWICZ: Good afternoon,  
10 Commissioners. Henry Karnilowicz. I'm the president of  
11 the South of Market Business Association.

12 First of all, I just want to really commend  
13 and applaud the Warriors for not giving up the boat and  
14 throwing in the towel and saying, Hey, look, we can't  
15 build on the piers, so we're going to Oakland, and we're  
16 going to build over there.

17 But, no. They stuck it out, and they really  
18 worked hard at it.

19 They didn't just go and say, Hey, we're going  
20 to do it. They did reach out to everybody to make it  
21 happen. So, I'm really proud of them.

22 As the president of the South of Market  
23 Business Association, I'm also involved with the  
24 merchants out in Bayview and in Dogpatch and so forth.

25 And what you're going to get from this,

1 because with the Warriors, they're going to have not  
2 just basketball, but other entertainment also. You'll  
3 have more people coming into the area, and that will  
4 trickle all the way down into Bayview and into the rest  
5 of South of Market. So, I think it's going to be a  
6 really great thing to have in the South of Market Area.

7 I can tell you right now that when it comes to  
8 businesses that are in the area around the Giants Park  
9 right now, once there's no games, a lot of those  
10 businesses have -- don't have too much going on. And  
11 this is going to really help them to do much better with  
12 the Warriors being there.

13 So, once again, I think they're a great team.  
14 My daughter just loves them. And if I didn't support  
15 them, she probably wouldn't talk to me again. So, I  
16 really urge you to please support the EIR and vote in  
17 favor.

18 Thank you.

19 CHAIRPERSON ROSALES: Thank you.

20 JOHN CAINE: Good morning. Happy Election  
21 Day. My name is John Caine.

22 I'm the owner of what will be the newest port  
23 restaurant in Mission Bay, located at Pier 50, at 295  
24 Terry Francois, just up the street from the arena. We  
25 have just named our new restaurant Atwater Tavern. We



1 are opened -- we plan to open in the spring.

2 I'm also the owner of Hi Dive restaurant,  
3 which has been at Pier 28-1/2 since 2004.

4 My family and I live in San Francisco, in  
5 North Beach, and care very much about the quality of  
6 life in this City.

7 I'm 100 percent in favor of this project  
8 proceeding immediately. My partners and I have reviewed  
9 the plans, the Draft EIR and the traffic mitigations,  
10 and believe that they will solve 100 percent of the  
11 potential traffic circulation problems in this area.

12 I speak from experience. Hi Dive is located  
13 at Bryant and the Embarcadero, and game day and event  
14 day traffic is a given. The City does an outstanding  
15 job of managing all the vehicle, pedestrian, and other  
16 traffic.

17 Mission Bay is a mixed-use neighborhood that  
18 needs more activity, public open space, and championship  
19 teams. I urge you to vote in favor.

20 Thank you.

21 CHAIRPERSON ROSALES: Thank you.

22 COMMISSION SECRETARY GUERRA: Will the  
23 following people please come up to the podium:

24 Sharon Johnson, Carla Tucker, Daniel Landry, and Susan  
25 Brandt-Hawley.

1 DENNIS MacKENZIE: Good afternoon,  
2 Commissioners. I'm Dennis MacKenzie, Round the Diamond  
3 Consulting and Education, and I also teach in the  
4 San Francisco public high schools.

5 First of all, I want to thank the OCII and the  
6 Planning Department and their staffs for all the  
7 comprehensive study and work you've done to ensure that  
8 the Mission Bay location for the Warriors Arena and  
9 Event Center can address numerous community issues,  
10 traffic concerns and challenges, successfully.

11 I also want to share that I support this  
12 Environmental Impact Report to be certified today for  
13 the benefit of everyone in the City.

14 And also I want to mention that -- thank you  
15 for responding to my comments. I provided you with some  
16 material in an E-mail this morning.

17 Also, you -- your comments in the EIR, thank  
18 you for addressing my comments regarding a proposal to  
19 include a high school classroom in the arena.

20 I just wanted to make one clarification, which  
21 I know it's a major effort that I've been doing for many  
22 years, and I want to thank the Warriors for all their  
23 longtime support for our kids and -- throughout the  
24 Bay Area.

25 And with that being said, my proposal, as you

1 commented in the EIR, I've never had the intention to  
2 build a new high school or a high school in the City or  
3 in the Mission Bay area. It had mentioned that briefly  
4 in your comments.

5 My idea is, hopefully, the Warriors will take  
6 this idea and address -- and incorporate it into their  
7 community foundation efforts to expand their education  
8 programs and use it as a model for which -- they have --  
9 the Warriors have tremendous influence throughout the  
10 country through the NBA. And I'm asking the Warriors to  
11 create this classroom of some sort, in any way they see  
12 fit, in order to expand that to their colleagues across  
13 the country, all the other NBA cities and ball teams.

14 Thank you very much.

15 CHAIRPERSON ROSALES: Thank you.

16 CARLA TUCKER: Good morning. My name is  
17 Carla Tucker, and I'm the program coordinator for  
18 Urban Ed Academy, which is an enrichment program in the  
19 Bay Area, serving 250 boys of color with Smart Saturdays  
20 educational program to transform young boys into eager  
21 learners so that they can be ready to excel.

22 We also have a group of wonderful volunteers  
23 from various communities and organizations, some that  
24 come out to support our boys and participate in programs  
25 and activities throughout the year. But this brings me

1 to talk about our NBA championship team, the Golden  
2 State Warriors.

3 As you know, they are just about to solidify  
4 their move to San Francisco, and in saying that, the  
5 Warriors Project will attract over 4,000 jobs, both  
6 permanent and construction.

7 Seeing that Bayview-Hunters Point has the  
8 highest unemployment rate, our families are very excited  
9 about the opportunity that this will bring to the City.

10 The Warriors have also already demonstrated a  
11 tremendous amount of community support throughout the  
12 Bayview community by providing tickets for kids and  
13 families to attend the professional games, and awarded  
14 several Bayview organizations grants, refurbishing our  
15 courts in our neighborhoods and showing the overall  
16 commitment to both health and education.

17 So, the Warriors' move to the San Francisco  
18 means so much more than basketball. This project will  
19 allow the public to have access and will also set the  
20 tone for better access to the waterfront, and eventually  
21 will add to the connection point to the waterfront  
22 projects like Hunters Point Shipyard and Candlestick  
23 Point.

24 The T Train service is also in desperate need  
25 of expansion, and the Warriors' move to Mission Bay will

1 generate more than \$40 million in upfront funds to pay  
2 for the transit improvement for the neighborhood,  
3 including community services. This is something that  
4 will greatly improve and benefit families in the Bayview  
5 community. And for that, we are so excited and grateful  
6 that they're coming over to the City.

7 Thank you.

8 DANIEL LANDRY: Good morning, Commissioners.  
9 Daniel Landry, for the record.

10 I'm currently chairing an organization called  
11 the New Community Leadership Foundation, and we would  
12 like to say we support the Warriors coming to  
13 San Francisco.

14 And the times that we came here before, I did  
15 speak briefly about we're excited about the  
16 entertainment opportunity, the venue, and just having a  
17 world-class arena here in San Francisco.

18 We know that this is just a first step of a  
19 long-term process, and as you know, the other hat I wear  
20 which is dealing with the community I come from, which  
21 is the Fillmore area, which is one of the best Warrior  
22 players ever, Phil Smith, came from here, San Francisco.  
23 The irony is just -- well, prove it.

24 And this being Election Day, I just want to  
25 say, too, you know, the Community Benefits Agreement

1 that we speak about at Heritage Center plays a great  
2 role in other projects like this project, the Warriors  
3 Project and Event -- you know, when you're having things  
4 coming to the City that bring so much opportunity,  
5 whether it's that or it's the Super Bowl being this --  
6 being the whole City.

7 And our organization, one of the things that  
8 I'm tasked with is how to be creative and get young  
9 people excited about development in a way that it  
10 impacts grass-root communities here in San Francisco.

11 So, that's one of the things that we want to  
12 help the Warriors, since we are natives here in  
13 San Francisco and been here since day one -- how to  
14 connect to the community at rock-bottom all the way up  
15 to the top.

16 But we think this project is big for the City,  
17 is definitely going to create opportunities, and we want  
18 to make sure all the laws that's on the book, 50 percent  
19 hiring and all that type of stuff, go forward.

20 Thank you.

21 CHAIRPERSON ROSALES: Thank you.

22 SHARON JOHNSON: Good morning. My name is  
23 Sharon Johnson.

24 I am a native San Franciscan. I am a longtime  
25 Warrior fan, and I am the program manager at the

1 Potrero Hill Neighborhood House. I am here to support  
2 this project with the Warriors.

3 I've worked with the Warriors for a long time.  
4 They've given us tickets so I could bring my youth to  
5 games. They've supported our educational efforts with  
6 the youth in our communities, and they've just -- this  
7 is a wonderful, wonderful opportunity to bring a  
8 championship team here to San Francisco.

9 I am here to say ditto to all of those who  
10 support this project, and look forward to welcoming the  
11 Warriors here to our community.

12 Thank you.

13 CHAIRPERSON ROSALES: Does the baby want to  
14 say something?

15 COMMISSION SECRETARY GUERRA: I'm calling, for  
16 the last time, Oscar James, Stuart Canning,  
17 D.J. Brookter, and Ramon Hernandez.

18 SUSAN BRANDT-HAWLEY: Good afternoon, Members  
19 of the Commission. I am Susan Brandt-Hawley, and it's  
20 hard to follow a baby sleeping in a Warriors' jersey,  
21 but I'll do my best.

22 We all support the Warriors. That's not the  
23 issue here today, but the public looks to this  
24 Commission to follow the environmental laws in every way  
25 before approving this project or considering approval.

1           You've received a number of letters from me  
2 and others regarding environmental problems, and yet the  
3 Final EIR that we just received a little over a week  
4 ago, with thousands of pages, the approvals are being  
5 rushed through, which is unfair to the Commission and  
6 unfair to the public, because a lot of the environmental  
7 questions have not been solved.

8           I would like to turn in, for the record, just  
9 a few letters that I've sent to you. But these are hard  
10 copies, in case you don't have them yet.

11           (Letters submitted to staff.)

12           I'd like to focus, in just this very short  
13 amount of time, on a really critical underlying issue  
14 and problem here that needs to be solved that we brought  
15 up in the Draft EIR comments in July -- that the EIR  
16 declined to study in any way the land-use consistency of  
17 this plan.

18           The South Mission Bay Redevelopment Plan sets  
19 out a very careful, planned community in these classic  
20 bare blocks to allow development of the biotech industry  
21 and other compatible uses.

22           The EIR did not study land use, claiming that  
23 this qualified as a secondary nighttime entertainment.  
24 And as I explained in my letter, none of the secondary  
25 uses -- nighttime entertainment, that's supposed to be



1 for bars and small evening establishments; a recreation  
2 building, which is being claimed, when this is actually  
3 entertainment, which is not an active recreation, but  
4 it's, in fact, something that people watch; or a public  
5 structure or use, which, in fact, this is not, because  
6 it's not a public building.

7           You can fix this problem by considering  
8 amendment of the Redevelopment Plan. But right now,  
9 this project is directly inconsistent and does not  
10 qualify for -- as a secondary, much less a primary use.

11           So, we'd ask you to take some more time, look  
12 as the EIR comments that we've submitted, and, in  
13 particular, take a hard look at these findings that are  
14 not supportable regarding the secondary use.

15           I'm not sure. Do I have more time here?

16           CHAIRPERSON ROSALES: I'll allow more time  
17 just to finish.

18           SUSAN BRANDT-HAWLEY: Okay.

19           Well, thank you very much for your attention.  
20 And we ask that you continue this, look at all the  
21 issues that have been raised.

22           And, again, the public is looking to you to  
23 make sure whatever is approved -- we believe, should be  
24 at a -- certainly, at another location -- is fully  
25 resolved and not go forward and create environmental

1 problems.

2 Thank you.

3 CHAIRPERSON ROSALES: Thank you.

4 COMMISSION SECRETARY GUERRA: Are there any  
5 others that would like to speak?

6 (No response)

7 Madam Chair, I have no further speakers.

8 CHAIRPERSON ROSALES: Okay. And there's no  
9 one in the overflow rooms?

10 There's two overflow rooms.

11 COMMISSION SECRETARY GUERRA: We checked.

12 CHAIRPERSON ROSALES: Okay.

13 We will close the Public Comment. Thank you,  
14 everyone, for speaking.

15 The time is 12:16.

16 I think my fellow Commissioners and I are a  
17 little tired, and I think we need a little break. So,  
18 if we can take a 30-minute break, I think that's fine,  
19 so that we can stretch our legs and come back for the  
20 balance of the calendar.

6                    CHAIRPERSON ROSALES:    Thank you.    It is 1:10  
7    and we are back in session.    Thank you so much for your  
8    patience.    We took a little longer than 30 minutes.

9                    Okay.    So, Public Comment is closed, but  
10    before I turn to my fellow Commissioners, I'd like to  
11    request staff to present a response to some of the  
12    comments that we heard.

13                    DEPUTY DIRECTOR OERTH:    Thank you, Chair  
14    Rosales.    Again, Sally Oerth, for the record.

15                    Commission Members, we do have a few staff who  
16    would like to respond to the information presented here  
17    in Public Comment, and first I'll call up Chris Kern  
18    from the Planning Department.

19  
20                    RESPONSE TO PUBLIC COMMENTS

21                    BY SENIOR ENVIRONMENTAL PLANNER KERN

22  
23                    SENIOR ENVIRONMENTAL PLANNER KERN:    Good  
24    afternoon.    Chris Kern with the Environmental Planning  
25    Division from the City Planning Department, and I'm part

1 of the team of City staff and consultants who have spent  
2 the last year and a half preparing the Environmental  
3 Impact Report that is before you today for  
4 consideration.

5 I wanted to talk briefly about that process  
6 and the function of CEQA.

7 The function of CEQA is to provide for  
8 informed decision-making by the public and public  
9 agencies about the environmental consequences of a  
10 proposed project.

11 It's an informational document. Its purpose  
12 is disclosure about environmental effects.

13 I feel strongly that the team and many of the  
14 expert consultants and City staff and members of the  
15 City Attorney's Office who contributed to the drafting  
16 of the Final Supplemental Environmental Impact Report  
17 that is before you today -- meets the requirements of  
18 CEQA, that it thoroughly discloses all of the  
19 potentially significant environmental effects of the  
20 project, that it identifies feasible mitigation measures  
21 that would reduce those impacts, and it identifies  
22 feasible alternatives that would substantially lessen  
23 one or more of the significant impacts of the project.

24 The Responses to Comments document, which  
25 together with the Draft Supplemental of the Subsequent

1 Environmental Impact Report form the final SEIR, if you  
2 are to certify it today, responds to all of the comments  
3 that we have received on the draft document, both during  
4 the public comment period as well as after the public  
5 comment period through October 7th.

6 At that point, we had a cutoff of what we were  
7 gonna respond to in the Responses to Comments document  
8 so that we could complete and finalize that document.  
9 However, we have received a number of comments since  
10 October 7<sup>th</sup>.

11 We responded to all comments that we received  
12 as of yesterday afternoon in writing, and you've been  
13 provided with the late comments and responses to those  
14 comments that have come in since that time starting  
15 about 6:00 p.m. last night.

16 And then, through earlier today at this  
17 hearing, we've received a number of additional comments.  
18 We have not prepared written responses to those  
19 comments.

20 However, I do want to assure you that this  
21 team of technical specialists and attorneys and City  
22 staff have reviewed all of the comments that have been  
23 submitted, and we do not, in our opinion -- our expert  
24 opinions, believe that the materials that have been  
25 submitted in the last 15 hours or so raise any new

1 issues.

2           They don't contain any substantial new  
3 information that would alter any of the conclusions  
4 reached or the analysis contained in the final SEIR  
5 before you.

6           The nature of the information and the comments  
7 in these late submittals can be characterized as really  
8 a disagreement amongst experts, and legal opinion, all  
9 of which are issues that we have already responded to in  
10 the Responses to Comments documents or addressed in the  
11 Draft SEIR.

12           Now, with that said, there are a few specific  
13 topics that I wanted to provide a little bit more  
14 clarification on as to how we've responded to those  
15 comments and how those -- how the issues raised in those  
16 comments are addressed in the documents that we've  
17 provided to you.

18           And to just frame that up, I'll -- we made a  
19 quick list of the topics that are covered by the  
20 comments that have been received, just again, in the  
21 last 15 hours or so.

22           They cover transportation, air quality, noise,  
23 greenhouse gases, and the AB 900 certification,  
24 biological resources and wetlands, hydrology, water  
25 quality and wastewater, utilities, geology, hazards,

1 recreation, wind and shadow, urban decay, the CEQA  
2 process, land use, economic issues, and environmental  
3 justice, and social and economic issues.

4 Of that topic, there no new issues that have  
5 not been already addressed and are not analyzed in the  
6 Final SEIR documents and the technical analyses and  
7 supporting documents that are in the record that we have  
8 provided.

9 Now, on a couple of points -- let's see -- I  
10 do have one additional errata, or really it's a minor  
11 change to one of the mediation measures that we wanted  
12 to make, and that is the air quality offset mitigation  
13 measure, Mitigation Measure MAQ 2-B.

14 That measure currently reads, "Pay a  
15 mitigation offset fee to the Bay Area Air Quality  
16 Management District Strategic Incentives Division in an  
17 amount not to exceed \$18,030 per weighted ton of ozone  
18 precursors per year."

19 We want to change that "not to exceed" to "no  
20 less than." And we have discussed that change with the  
21 project sponsor, and the sponsor has indicated that they  
22 are agreeable to making that change.

23 Now, that change to the mit measure -- the  
24 mitigation measure is partially in response to a late  
25 comment letter that we received from the Bay Area Air

1 Quality Management District.

2 That letter and our response to that letter  
3 are contained in the packet we distributed to you this  
4 morning, but we didn't include that change to the  
5 measure in that response. That was an oversight.

6 Now, the comments from the Air District,  
7 again, really focus on the amount of the offset  
8 mitigation fee.

9 And the Planning Department staff, our air  
10 quality specialists both in-house as well as  
11 consultants, have been having ongoing discussions with  
12 the Air District about the amount of the offset fee  
13 since before publication of the draft.

14 We are continuing those discussions, and  
15 clearly you can see from their letter that we haven't  
16 reached a final agreement with the Air District, but we  
17 intend fully to continue those discussions, because we  
18 would very much like to reach an agreement with the Air  
19 District on a workable offset fee as a mitigation  
20 approach not only for this project, but that we could  
21 use for future projects.

22 That said, we in the Responses to Comments  
23 document, in recognition to the fact that we hadn't yet  
24 reached a final agreement with the Air District about  
25 the details of that mitigation measure and its



1 implementation -- we added another option to that  
2 mitigation measure, and that is a change that's in the  
3 Responses to Comments document.

4 That additional option allows the sponsor to  
5 directly implement an Emissions Offset Project as an  
6 alternative to entering into an agreement with the Air  
7 District to implement an offset.

8 And I wanted to note that the City has done  
9 exactly that -- has used that same mitigation measure  
10 approach previously for the America's Cup event.

11 That EIR included an Emissions Offset Project  
12 to offset emissions generated by the event -- traffic  
13 and spectator boats, et cetera, to that event.

14 That offset project was a shore-site power  
15 facility at the Port's dry dock facility, which allows  
16 ships at dry dock to hook up to grid power as opposed to  
17 running their diesel engines, and it offsets a  
18 significant, you know, amount of emissions.

19 That's an ongoing benefit to the City and to  
20 the residents in the area, and has been implemented  
21 successfully. So, we feel that by providing that second  
22 option, we really further support the feasibility of  
23 implementing an emissions offset.

24 Let's see. On the topic of air quality, we  
25 also wanted to note that as a result of some of the

1 project refinements between the publication of the Draft  
2 and the Final -- and these are really refinements around  
3 the construction process for the project, including  
4 additional de-watering and the on-site treatment of  
5 hazardous soils by use of the pugmill -- there is a  
6 slight increase in the average daily construction  
7 emissions of about 2 to 5 percent, as well as, those  
8 emissions would also be attributable to construction of  
9 the center platform variant, because there would be  
10 some -- you know, additional construction activities  
11 related to that variant.

12           We believe that that 2 to 5 percent increase  
13 in construction emissions is not a substantial increase  
14 over what was reported in the Draft EIR and would not  
15 result in a substantial increase in severity of any the  
16 significant facts reported in the Draft EIR.

17           We would also note that the offset mitigation  
18 measure that I had just -- was just discussing would  
19 more than offset the construction emissions. That  
20 offset mitigation measure is -- offsets both the  
21 operational emissions which exceed the emissions during  
22 construction of the project.

23           So, we feel that that issue has been fully  
24 addressed in the EIR and the Responses to Comments  
25 document.

1           With respect to the U.C.S.F. comments  
2 regarding improvements to the Mariposa Pump Station to  
3 address ongoing and existing wastewater, really,  
4 transmission, as opposed to treatment, issues in the  
5 project area, the SFPUC has -- and the Department of  
6 Public Works, Planning staff, our consultants, and  
7 U.C.S.F. have again been in discussion over these issues  
8 since before the publication of the Draft.

9           The PUC has already implemented, as noted in  
10 the Responses to Comments document, interim fixes that  
11 address the transmission capacity shortfall in the near  
12 term, and is right now working on finalizing design of a  
13 long-term project which will be implemented long before  
14 the capacity of the current system is exceeded.

15           And just to explain that further, the analysis  
16 in the Draft EIR and in the Response to Comments  
17 demonstrates that sufficient capacity is available now  
18 and will be available at the time that the arena project  
19 is completed.

20           It's only with cumulative projects with a  
21 build-out of the plan and of the U.C.S.F. planned  
22 facilities that there's an issue with future  
23 infrastructure capacity.

24           That issue has not been missed. The City is  
25 working on it and fully intends to provide the required

1 infrastructure and whatnot before it's needed.

2 Let's see. I just want to make sure I've  
3 caught all the topics that we want to discuss.

4 Oh. So, with respect to comments -- late  
5 comments received about the ability of the EIR to rely  
6 on compliance with the City's NPDES Waste Discharge  
7 Permit -- that's a permit under the Clean Water Act for  
8 the Southeast Wastewater Treatment Plant -- again, the  
9 concerns raised about a record of or a history of  
10 violations, we think, is a bit of a mischaracterization,  
11 but that concern was -- was noted in comments received  
12 on the Draft EIR, and we have provided responses on that  
13 topic in the Responses to Comments document.

14 We've had discussions with SFPUC staff, and  
15 really we think a more accurate characterization of that  
16 history is that the regulatory process in the permit  
17 establishes discharge limitations. Exceedances do  
18 occasionally occur.

19 There is a robust regulatory process that the  
20 SFPUC complies with to report any exceedances to its  
21 discharge limits and to take corrective actions, and  
22 that is really, in the SFPUC's opinion, you know, to be  
23 expected through the regulatory process and really  
24 evidence of the -- how the regulatory process is  
25 supposed to function.

1           And then finally, I wanted to address some  
2 concerns raised about the enforceability implementation  
3 of mitigation measures and improvement measures, and  
4 commitments made on the part of the sponsor and the City  
5 through this project and your approval actions.

6           One of the actions before you is, if you  
7 were -- are to certify the Final EIR, is to adopt an  
8 MMRP, a Mitigation Monitoring and Reporting Program.

9           The MMRP provides a very detailed and lengthy  
10 documentation of the parties responsible for  
11 implementation of, you know, all of the mitigation and  
12 improvement measures, as well as the parties responsible  
13 for monitoring and reporting, and what the compliance  
14 actions are.

15           In this case, we've gone a little bit further  
16 than we normally do in that we have included, really in  
17 order to improve and simplify kind of the ongoing  
18 monitoring process of the project, an annual MMRP report  
19 to be submitted by the project sponsor, that reports on  
20 the current status at the time of the report of  
21 compliance with all of the measures listed in the MMRP.

22           And there is an introduction to the MMRP which  
23 identifies the enforcement tools available both to your  
24 Commission and to other City departments that have --  
25 that you will be delegating implementation

1 responsibilities to. And they are robust and adequate  
2 in our view.

3 And then, in addition to that all of that, the  
4 Planning Department has recently created and has staffed  
5 now a new position -- full-time position dedicated  
6 solely to mitigation monitoring and condition of  
7 compliance. So, something that, while we had the -- we  
8 think, the capability to do in the past, we have even  
9 more resources dedicated to that function than again we  
10 had before.

11 I think that's all that I have, unless you  
12 have questions about the EIR or the MMRP process.

13 CHAIRPERSON ROSALES: Any questions from the  
14 Commissioners?

15 (No response)

16 CHAIRPERSON ROSALES: On these topics, I don't  
17 believe there's any questions right now.

18 SENIOR ENVIRONMENTAL PLANNER KERN: Great.  
19 Thank you very much. I'll give it back to Sally.

20 DEPUTY DIRECTOR OERTH: Thank you, Chris.

21 Next, I'd like to ask Adam Van de Water to  
22 address some information, and after that, Jim Morales  
23 will address.

1                   RESPONSE TO PUBLIC COMMENTS  
2                   BY PROJECT MANAGER VAN de WATER  
3

4                   PROJECT MANAGER VAN de WATER: Thank you,  
5 Commissioners, Director Bohee, for your attention to  
6 detail on this.

7                   Two items related to the Fiscal Feasibility  
8 Analysis. There is a letter from the Controller's  
9 Office that's submitted to the administrative record  
10 concurring with the Mission Bay Development Group's  
11 analysis of the tax increment available both from the  
12 project and from the reduced intensity alternative to  
13 the project.

14                  And we received, as part of the documents  
15 received late last night, 104 pages from this Marin  
16 reserve law firm, including an analysis from the Marin  
17 Economic Consultants questioning some portions of our  
18 feasibility. I wanted to read a few things into the  
19 record related to that.

20                  The report itself argued that biotechnology  
21 would be a better use fiscally for the City, and there  
22 are five reasons why we disagree.

23                  Further, the project is a net financial  
24 benefit to the City and provides a means to invest in  
25 and improve the City's transit infrastructure.

1 Point 1, in calculating the induced demands,  
2 the consultant, Mr. Jon Haveman, compares 2,000 added  
3 biotech employees to the permanent staff of the  
4 Warriors, excluding the up to 1500 event staff that  
5 would serve concessions, event management, janitorial,  
6 parking, and other functions up to 225 times per year.

7 He also assumes no independent utility of any  
8 of the upfront transportation improvements -- the  
9 purchase of the four lightrail vehicles, the  
10 installation of the crossover track, signals and  
11 signage -- for the neighborhood or for the SFMTA.

12 He attributes nearly three quarters of a  
13 million dollars in ancillary benefits to the alternative  
14 biotech proposal and zero to the proposed project, even  
15 though the project includes two office buildings and  
16 could include biotech uses.

17 The report asserts the City would receive  
18 greater net gain from a biotech center rather than the  
19 Event Center, but only if an ongoing -- if ongoing  
20 transit costs associated with the biotech center are  
21 assumed to be zero. Given the estimated 2,000  
22 additional employees that a biotech center would add,  
23 this is a false premise.

24 In the analysis, savings from zeroing out  
25 ongoing transit costs are partially offset by the loss



1 of saving initial tax proceeds.

2 Finally, hotel taxes, the report raises  
3 questions over the capacity of the City's hotel market  
4 to accommodate additional event attendants -- attendees  
5 without simply displacing other overnight visitors, and  
6 whether event attendees who are already staying in the  
7 City when the events were held at Oracle in Oakland.

8 This analysis does not account for the  
9 interplay of hotel room prices. Since fiscal year 2011,  
10 the City's hotel room occupancy rate has increased  
11 modestly from an average of 81 percent to 86.4 percent  
12 in 2015. Over the same period, average daily rates for  
13 hotel rooms have increased by more than 50 percent.

14 The City's hotel market is constrained, but  
15 our experience is that limits on capacity have caused  
16 room rates to increase and corresponding hotel tax  
17 revenues as capacity is filled.

18 There are numerous hotel projects currently  
19 planned or being built, including the Block 1 site on  
20 3rd Street and Channel in Mission Bay, and we stand  
21 behind the fiscal feasibility analysis that was prepared  
22 by our outside expert, EPS, was peer-reviewed by Keyser  
23 Marston & Associates, and was prepared in consult with  
24 and concurrence by the Controller's Office.

25 Thank you.

1                   RESPONSE TO PUBLIC COMMENTS  
2           BY GENERAL COUNSEL AND DEPUTY DIRECTOR MORALES  
3

4           GENERAL COUNSEL MORALES:   President Rosales,  
5 Members of the Commission, my name is Jim Morales.  I'm  
6 the General Counsel and Deputy Director for OCII, and I  
7 just wanted to take a brief opportunity to respond a  
8 couple of letters that were received this morning by  
9 counsel for the opponents to the project, Mission Bay  
10 Alliance.

11           Susan Brandt-Hawley has submitted a letter  
12 that basically says that the proposed Event Center does  
13 not qualify as a secondary use under the grounds that  
14 were stated in the staff report provided to this  
15 Commission and to the Director.

16           Mr. Tom Lippe has also provided a letter that  
17 says that we followed the wrong procedure.  He also  
18 agrees with Ms. Brandt-Hawley that this is not a  
19 secondary use, but claims that we should have used a  
20 variance procedure to authorize this project.

21           I just wanted to emphasize the most important  
22 fundamental flaw with their arguments, and that is that  
23 it ignores the redevelopment authority that still exists  
24 for this Commission and for the Executive Director to  
25 exercise.

1           We are all painfully aware of the dissolution  
2 of redevelopment that's occurred over the last several  
3 years, but that hasn't dissolved the redevelopment  
4 authority in this context for this project and for this  
5 project area.

6           In fact, dissolution law and the State have  
7 confirmed that Mission Bay South, along with a few other  
8 project areas, are continuing obligations of the  
9 Successor Agency.

10           And with that, we have a contractual  
11 obligation called the Mission Bay South Owner  
12 Participation Agreement, and the Redevelopment Plan,  
13 that requires the agency to approve -- consider and  
14 approve development that meets the objectives of  
15 redevelopment. And that's what this project does.

16           This, they ignore, and look at what I would  
17 call a very prescriptive approach to how the land use  
18 should be determined in this area.

19           First, turning to the secondary use, the  
20 Redevelopment Plan divides uses into principal and  
21 secondary uses.

22           Staff, in recommending to the Executive  
23 Director that this constitutes a secondary use, has  
24 focused on four secondary uses: The nighttime  
25 entertainment, recreation, and public structure,

1 non-industrial use of the site.

2           Some of these terms have definitions in the  
3 Redevelopment Plan. Some do not. For example,  
4 "recreation" is not defined. "Nighttime entertainment"  
5 is defined.

6           In Ms. Brant-Hawley's view, it is meant to  
7 only include small venues -- small nightclubs, small  
8 places for people to gather. But, in fact, there are no  
9 size limitations on nighttime entertainment, and, in  
10 fact, some of the categories that are listed as possible  
11 nighttime entertainment venues could be very large.

12           And so, staff has recommended that  
13 nighttime entertainment secondary use is an appropriate  
14 one to consider.

15           In terms of recreation, Ms. Brandt-Hawley  
16 claims that this is not really recreation, it's actually  
17 entertainment, which, of course, is seemingly  
18 inconsistent with her views about nighttime  
19 entertainment.

20           But the definition of "recreation" must  
21 certainly include athletic events where people can  
22 observe, as well as other events that may occur that  
23 they will go to see for their -- in their recreational  
24 time.

25           Finally, on the secondary use, both public

1 structures and uses that are non-industrial are listed  
2 as permissible secondary uses in the Redevelopment Plan.  
3 These are also not defined in the Redevelopment Plan,  
4 and the -- staff is recommending to the Director that  
5 you and she exercise your discretion under redevelopment  
6 law under the enforceable obligations that remain in  
7 existence to interpret these terms to include a  
8 permissible use.

9 I just wanted to highlight also, since we're  
10 on the topic of secondary use, that the standard is not  
11 just whether or not there is a listed secondary use,  
12 which there is, but it's also a determination by the  
13 Executive Director to make a positive contribution to  
14 the character of the plan area, that is, the Mission Bay  
15 South area, based on consistency with the secondary use  
16 designation that I've already described -- "at the size  
17 and intensity contemplated, and at the proposed  
18 location, will provide a development that is necessary  
19 or desirable for and compatible with the neighborhood or  
20 the community."

21 You have received a 29-page proposed secondary  
22 use determination that reviews the facts that support  
23 this. You've also heard testimony today that further  
24 supports the determination to be made by the Executive  
25 Director. You've heard about the jobs, the benefits to

1 the community, to businesses, to the richness of San  
2 Francisco, all, of course, which go to the necessity and  
3 desirability of this use.

4           Also, it's compatible. You've heard from  
5 U.C.S.F. across the street, you've heard from businesses  
6 in the area, and you've here heard from residents, all  
7 of which have testified that this is desirable and  
8 arguably compatible with that neighborhood, something  
9 that is desired and wanted in the area. So, you and the  
10 Executive Director certainly have the information to  
11 make this determination.

12           I just wanted to turn to Mr. Lippe's letter,  
13 and he essentially argues that you should have used a  
14 variance process, and cites both State planning law and  
15 the Planning Code.

16           First, as I mentioned at the beginning, this  
17 is an exercise of redevelopment authority that has  
18 survived dissolution. It grants to this Commission and  
19 to the Executive Director very broad discretion to  
20 determine the appropriate uses that should be allowed in  
21 the project area, that will alleviate blight and fulfill  
22 the redevelopment objectives.

23           It is not bound -- these decisions are not  
24 bound by the State planning laws. They are not bound by  
25 the San Francisco Planning Code. Indeed, the

1 Redevelopment Plan adopted by the Board of Supervisors  
2 over 15 years ago explicitly states that the Planning  
3 Code has been superseded by the land use controls of the  
4 Redevelopment Plan.

5           So, the entire variance procedure and  
6 standards are simply not relevant to your consideration  
7 today and to your determination.

8           Also, in fact, the State provisions that he  
9 cites regarding variance are not applicable in any event  
10 to a charter city such as San Francisco.

11           Mr. Lippe also claims, I think, somewhat  
12 ironically that we should follow a variance and  
13 shouldn't -- you shouldn't amend the Design for  
14 Development.

15           The Design for Development, as you know, is an  
16 ancillary document to the Redevelopment Plan. This  
17 project meets all of the land use requirements of the  
18 Plan itself -- the Redevelopment Plan itself, but does  
19 require a few amendments to the Design for Development.

20           The agency, this Commission, and the Director  
21 certainly have the discretion to determine what would be  
22 the best approach to review and consider approval of a  
23 project.

24           It could consider a plan amendment. It could  
25 consider a Design for Development amendment. It could

1 consider a variance or variations as they're described  
2 in the Redevelopment Plan.

3 And the exercise of that discretion through  
4 very careful of review of these options, staff has  
5 recommended to the Director and to this Commission that  
6 you use, one, secondary use determination and an  
7 amendment to the Design for Development to fit the  
8 unique qualities of this project.

9 And so, with that, I'm available to answer any  
10 questions, or if you have any other comments, I'm  
11 certainly willing to respond.

12 CHAIRPERSON ROSALES: Thank you, Mr. Morales.

13 Thank you, everyone on the staff. Thank you  
14 for those explanations.

15 Okay. So, we're going to take Items 5-A and  
16 5-B first, because one is the certification of the SEIR  
17 and the other one is the adoption of CEQA findings, but  
18 I think before we entertain questions, comments, or  
19 motions, Commissioner Mondejar, were you interested in  
20 making a statement?

21  
22 COMMISSION DISCUSSION AND ACTION  
23

24 COMMISSIONER MONDEJAR: Yes. In the interest  
25 of full disclosure, the Filipina Women's Network, a



1 non-profit organization of which I am a board member,  
2 receives donations from the Golden State Warriors. This  
3 donation goes to our mentoring program, and I do not  
4 personally benefit from these donations, and it will not  
5 affect my judgment.

6 CHAIRPERSON ROSALES: Thank you.

7 So, with that, do any Commissioners have  
8 questions, comments?

9 COMMISSIONER BUSTOS: I do.

10 CHAIRPERSON ROSALES: Commissioner Bustos.

11 COMMISSIONER BUSTOS: First, I want to thank  
12 the public for being here. I know it's been a long  
13 meeting, and I'm glad actually we moved it up a bit so  
14 we could take our time to actually hear what everyone  
15 has to say. So, thank you.

16 And then, you know, full disclosure, I am not  
17 a sports fan. I have never been a sports-type person.

18 I never understood why my brothers and sisters  
19 would jump up and down and say "We won" when they didn't  
20 play anything except watch the television and see  
21 someone else playing -- on a court or on a field  
22 playing. They're the ones that won. They didn't -- my  
23 brothers and sisters didn't.

24 But anyway, so I have never really been into  
25 sports. So, I say that so you all know that I'm trying

1 to be as objective as possible.

2 I also want to thank the staff at OCII. I  
3 mean, they have been working for years on this project.  
4 I remember when I was on, you know, the Redevelopment  
5 Commission, and, you know, there was a different use for  
6 that particular site.

7 So, this is -- it's great to see that we're  
8 finally coming to a point where something is moving and  
9 happening there over there on 16<sup>th</sup> and 3rd.

10 You know, in looking at the report and sort of  
11 hearing from folks, I'm really pleased that the SBE  
12 numbers are at 50 percent. You know, we love that,  
13 because you hire folks from the community, not only just  
14 in terms of the construction work, which is very  
15 important -- as I mentioned before, my dad was a  
16 construction worker and worked on many of the iconic  
17 buildings in San Francisco. And it allows me, as his  
18 son, his baby, to see his presence and his fingerprint  
19 on our city. And I believe that the workers who will  
20 work on this particular project will be able to do the  
21 same.

22 When it comes to the arts, remember I would  
23 love for you guys to look at local artists when you look  
24 at furnishing some of the stuff in the office as well as  
25 inside.

1 I'm really pleased that the traffic issues  
2 have been mitigated. I'm really pleased that the  
3 Warriors have actually listened to us and listened to  
4 the Commission and listened to the community. And, you  
5 know, it's been very thoughtful, and I really appreciate  
6 that.

7 That fact that there's been a broad sense of  
8 community support has really impressed me. You know, if  
9 you're able to go through Ms. Woods from the CAC and she  
10 supports you, then you've done your homework. She is  
11 very diligent. She's an incredible voice for the  
12 community.

13 But you brought along labor, other  
14 non-profits, as well as neighbors, including U.C.S.F. to  
15 your side, which I commend you for doing that.

16 I think the process that you took to get to  
17 this point in something as complex as this could be a  
18 standard for development to come in the City.

19 So, Madam Chair, I would love to move this  
20 idea.

21 CHAIRPERSON ROSALES: Okay.

22 Can we hold on the motion for a minute --

23 COMMISSIONER BUSTOS: Sure.

24 CHAIRPERSON ROSALES: -- so we -- just to give  
25 the other Commissioners a chance to comment?

1 Commissioner Singh.

2 COMMISSIONER SINGH: I think it's a very good  
3 project when I see that, and it's -- you know, it's  
4 really very good.

5 As Commissioner Bustos said, that traffic and  
6 parking has been mitigated, and also support of the  
7 U.C.S.F. Associate Chancellor is here.

8 And I have a question for Mr. Lee, the  
9 compliance.

10 Mr. Lee, I just want to know that, you know,  
11 minority contracts -- SB, WB -- all this, you know, can  
12 you explain that?

13  
14 RESPONSE TO COMMISSIONER COMMENTS

15 BY CONTRACT COMPLIANCE SUPERVISOR LEE

16  
17 CONTRACT COMPLIANCE SUPERVISOR LEE: Sure.

18 Raymond Lee, Contract Compliance Supervisor  
19 with OCII.

20 I have to commend the Warriors and their team  
21 in terms of working with us in developing a team that we  
22 feel is diverse. They have met the objective of the SBE  
23 program within OCII. So, the figures that are  
24 represented that you see in your package is what it is.  
25 It is meeting the objective of our program.

1 COMMISSIONER SINGH: Thank you.

2 I second the motion.

3 CHAIRPERSON ROSALES: Okay.

4 The motion, I haven't asked yet. Now we know  
5 we have placeholders.

6 Commission Pimentel.

7 COMMISSIONER PIMENTEL: Good afternoon.

8 I'm so excited to see so many people that have  
9 taken time out of their day today to show up and express  
10 their opinion.

11 I want to applaud the Warriors. I really  
12 related to the gentleman who spoke about having a child  
13 and having a family and building memories, and that we  
14 live in a major city, and we need to have a world-class  
15 stadium as well.

16 And also, seeing how the plans have evolved  
17 over time based upon the community feedback and working  
18 with local organizations and non-profits, and taking  
19 your community efforts and implementing them in San  
20 Francisco where you guys would like to build your  
21 stadium.

22 So, thank you.

23 CHAIRPERSON ROSALES: Commissioner Mondejar.

24 COMMISSIONER MONDEJAR: Yes. Thank you, Chair  
25 Rosales.

1           So, I go with what the rest of my fellow  
2 Commissioners have said.

3           I just wanted to applaud the staff, especially  
4 Executive Director Bohee. The records, the reports, the  
5 briefings that we have received have been very thorough  
6 and complete, and you've been able to -- and your staff  
7 has been able to respond to our questions and our  
8 concerns.

9           And I also want to commend the Warriors for  
10 listening to the community, and the -- the community  
11 organizations are right here. I just wish there are  
12 more women's organizations that have responded and have  
13 supported the Warriors. I see a lot of men in this  
14 room.

15           But I also wanted to make sure that Ms. Woods'  
16 concerns about the inconsistencies in parking and  
17 traffic are addressed, which I'm confident will be. And  
18 I hold Ms. Woods to make sure that these concerns are  
19 addressed and are -- and are completely satisfied.

20           And really, I am happy to support this motion.

21           And I also wanted to commend the MTA and the  
22 Planning Commission. They really have provided the  
23 information and answers to the questions and concerns  
24 about parking and traffic, and also with the things that  
25 are coming up in the planning of this -- of the

1 transportation especially.

2           So, I support the motion that has not been  
3 presented yet.

4           CHAIRPERSON ROSALES: Yes.

5           I just wanted to add my comments and ask a  
6 question of the Executive Director before I take the  
7 motion and the second.

8           I'm not going to repeat what my fellow  
9 Commissioners have said, because I agree with all of it.

10           I've been a member of the City family for -- I  
11 won't tell you how long, but for decades, and I've seen  
12 many project with community engagement and attempting at  
13 least to listen to what the community has to say, and  
14 I've witnessed many consultants and City employees,  
15 attorneys, et cetera, put in a lot of effort, but this  
16 one pretty much I have to say tops almost all of them in  
17 my experience.

18           And, you know, even with the opposition  
19 stating, you know, their concerns that are always, you  
20 know, valid concerns, I think our responses are  
21 adequately -- have been made on the record.

22           I very much appreciate the collaboration with  
23 U.C.S.F., the Giants, but I really have to send a lot of  
24 kudos to SFMTA with the traffic management, because I  
25 was probably the lone Commissioner that kept saying I

1 drive from downtown to Bernal Heights right now on  
2 non-game days and I feel those impacts. So, I thank --  
3 I want to give kudos there.

4 But also the funding mechanism -- that's  
5 critically important -- of the community -- the Mission  
6 Bay community in particular voiced, that was necessary,  
7 and I certainly support that a hundred percent.

8 So, with that, my question is to the Executive  
9 Director on enforcement, because I think it's a valid  
10 concern.

11 I read as much as I can without going to sleep  
12 about the Mitigation Monitoring and Reporting Program,  
13 and I do see, you know, responsibilities allocated.  
14 It's all laid out very nicely, but I just want to make  
15 sure and I just want you to comment on the mechanisms  
16 that we, as the principal agency, responsible, will take  
17 to ensure that we have staff, we have agreements, we  
18 have everything it takes to ensure that the monitoring  
19 will take place.

20 EXECUTIVE DIRECTOR BOHEE: Thank you, Madam  
21 Chair.

22 Tiffany Bohee for the record.

23 Madam Chair and Commissioners, your  
24 findings -- your CEQA findings resolution under 5-B,  
25 there is a resolved clause under 5-B in those CEQA



1 findings, which include the Mitigation Monitoring and  
2 Reporting Program, that provide for the Commission to  
3 delegate the authority to enter into agreements with  
4 other entities, including other City departments or  
5 other entities as we see fit in order to assist OCII in  
6 the enforcement of the Mitigation Monitoring and  
7 Reporting Program, and that procedure you'll see through  
8 the annual budget process.

9           That's one that we're making sure, as we move  
10 forward, there are adequate resources. One, there are  
11 adequate resources today, and certainly there will be in  
12 the future.

13           Two, as you heard from Chris Kern at the  
14 Planning staff, there are the unusual step the team has  
15 taken in the preparation of the Mitigation Monitoring  
16 Reporting Program, not just an annual report on all of  
17 the measures that are required to be followed, but also  
18 there are significant enforcement measures and  
19 corrective action that are provided for that the  
20 Commission and other entities may take. And they  
21 include withholding permits, court remedies, criminal  
22 prosecution, et cetera. So, there is an enforcement  
23 mechanism with teeth in addition to reporting and  
24 adequate resources for staff.

25           CHAIRPERSON ROSALES: Great. Thank you.

1           So, now, with that, are there any other  
2 questions?

3           I will entertain a motion.

4           COMMISSIONER BUSTOS:   So moved.

5           CHAIRPERSON ROSALES:   Moved by Commissioner  
6 Bustos.

7           COMMISSIONER SINGH:    Second.

8           CHAIRPERSON ROSALES:   Seconded by Commissioner  
9 Singh.

10          Madam Secretary, please call the roll on 5-A.

11          COMMISSION SECRETARY GUERRA:   Commission  
12 Members, please announce your vote when I call your name  
13 for 5-A.

14          Commissioner Pimentel.

15          COMMISSIONER PIMENTEL:   Yes.

16          COMMISSION SECRETARY GUERRA:   Commissioner  
17 Mondejar.

18          COMMISSIONER MONDEJAR:   Yes.

19          COMMISSION SECRETARY GUERRA:   Commissioner  
20 Singh.

21          COMMISSIONER SINGH:    Yes.

22          COMMISSION SECRETARY GUERRA:   Commissioner  
23 Bustos.

24          COMMISSIONER BUSTOS:    Yes.

25          COMMISSION SECRETARY GUERRA:   Madam Chair

1 Rosales.

2 CHAIRPERSON ROSALES: Yes.

3 COMMISSION SECRETARY GUERRA: Madam Chair, I  
4 have five ayes.

5 CHAIRPERSON ROSALES: Okay.

6 With the Commission's permission, we have the  
7 same call on 5-A in terms of motion and second. So,  
8 it's been both moved by Commissioner Bustos and seconded  
9 by Commissioner Singh.

10 Please call the roll.

11 COMMISSION SECRETARY GUERRA: Commission  
12 Members, please announce your vote when I call your  
13 name.

14 Commissioner Pimentel.

15 COMMISSIONER PIMENTEL: Yes.

16 COMMISSION SECRETARY GUERRA: Commissioner  
17 Mondejar.

18 COMMISSIONER MONDEJAR: Yes.

19 COMMISSION SECRETARY GUERRA: Commissioner  
20 Singh.

21 COMMISSIONER SINGH: Yes.

22 COMMISSION SECRETARY GUERRA: Commissioner  
23 Bustos.

24 COMMISSIONER BUSTOS: Yes.

25 COMMISSION SECRETARY GUERRA: Madam Chair

1 Rosales.

2 CHAIRPERSON ROSALES: Yes.

3 COMMISSION SECRETARY GUERRA: Madam Chair, I  
4 have five ayes.

5 CHAIRPERSON ROSALES: Okay. So, 5-A and -B  
6 are adopted.

7 Okay. So, we have 5-C, -D, and -E, but before  
8 moving to action, we would like to hear from our  
9 Executive Director on 5-E on the secondary use  
10 determination.

14 will use in making my determination on the secondary use  
15 finding.

16 Before making that determination, does the  
17 Commission have any additional questions?

18 CHAIRPERSON ROSALES: Any members that would  
19 like to ask the Director on the secondary use issue?
